Front left

1 Common Crab Apple

Medium mature tree. To contain spread and improve light and space all round: Reduce and reshape crown by 25-30% all round to suitable new growing points. Thin and clean out crown, remove deadwood and sucker growth. Lift canopy all round by 0.5-1m and balance crown.

Front right

2 Common Crab Apple

As for item 1 above

Rear left side

3 Horse Chestnut

Mature tree. To improve condition and light to the garden. Thin crown by 20-25% evenly to branch ends. Clean out crown, remove deadwood, weak and suppressed and broken branches. Lift and balance crown.

Rear left

4 Horse Chestnut

Larger mature tree. As for item 3 above

5 London Plane

Very large mature multistem and widespreading tree. To contain spread, lessen weight on branch ends and improve light, space and clearance all round: Reduce crown all round by 25-30% to previous reduction points, retain crown continuity. Thin crown by 20-25% throughout, remove deadwood, weak and suppressed branches and suckers. Lift canopy all round by up to 2m and balance crown.

6 Lime

Very large mature very tall specimen tree with a pronounced lean. To contain spread, lessen weight in upper crown and maintain structural integrity and to improve light and space all round: Reduce crown in height by 25-30% and round off tops. Reduce back lateral crown spread all round by 20-25%. Thin and clean out crown, remove deadwood, weak and suppressed branches and sucker. Lift canopy all round by up to 2m. Balance crown.

7 apple

Very large mature tree, rear right side. To contain spread and improve condition, light and space all round: Reduce crown all round 25-30% to previous reduction points, retain crown continuity. Thin and clean out crown, remove deadwood and all sucker regrowth. Lift canopy all round by 1-2m, balance crown. Remove low stumped branches to maintain trunk.
