Dear Mr Gracie,

I have spent weeks trying to reach you by telephone (to no avail) whilst also attempting to define your email address. I therefore hope this email reaches you.

I recently objected to the planning request for the construction of an additional level and construction of a mansford roof on the conversion of 4-5 Loveridge Mews (see below)

My objection is due to anxiety regarding the reduction of light getting into my property (10 Loveridge Mews which is opposite 4-5 Loveridge Mews). My concerns have been confirmed with the erection of the scaffolding on 4-5 Loveridge Mews; I now have to regularly turn the lights on (during the day) when I am downstairs, something which I have never previously had to do in the 15 years I have owned the property.

I would like a speedy correspondence for the council to explain to why works appear to be going ahead without any consultation and no acknowledgement of my objection. I have regularly been onto the council's website and permission is yet to be granted for the erection of the mansford roof. However, it would appear (as indicated by the scaffolding) that works will be going ahead. It is my understanding that when permission is granted for planning, the changes should not have a negative impact on the immediate neighbours.

I would like to raise that I did not object to the conversion of 4-5 Loveridge but I am firmly against an additional level being constructed due to the impact on my property.
