T3: SYCAMORE: TO 30% THIN AND REMOVAL OF DEAD WOOD

T4: PLUM: TO 20% REDUCTION TO ALLOW LIGHT FILTRATION AND KEEP THE TREE IN SCALE WITH THE GARDEN
