Thank you for your comment regarding the above application for the replacement of existing windows like for like.

This has brought to my attention that the Design and Access/Heritage Statement had not been made available online. This has now been rectified.

With regards to other relevant information required to assess the proposal, existing and proposed drawings have been submitted and can be viewed online showing that the design of the front and rear windows are to be replaced with identical windows.

However, the annotations on the drawings need to be amended to reflect the similarity in the design of the windows. I am currently awaiting for the rear and front elevation drawings to be amended by annotating them as "Existing and Proposed".

The applicant has also provided photos of the windows.

The officer who originally validated the proposal had processed a planning application reference: 2015/1010/P which was not required. This has now been withdrawn and only Listed Building consent is now going through the process – reference as above.

As such, I would therefore request that you again assess the proposal and in view of all the information provided, whether you would be happy to withdraw your objection.
