T4: Indian Bean Tree - Remove Deadwood.

T5: Medium Plum - Reduce crown by 2m. Remove epicormic growth.

T6: Pittosporum - Lightly reduce and tidy to shape.

T7: Tulip tree - Reduce two lowest limbs by 1-2m to reshape
