ENFORCEMENT NOTICE

OF 14 St Augustine's Road LONDON NW1 9RN

1. THIS IS A FORMAL NOTICE which is issued by the Council because it appears to them that there has been a breach of planning control, under Section 171 A (1) (a) of the above Act, at the land described below. They consider that it is expedient to issue this notice, having regard to the provisions of the development plan and to other material planning considerations. The Explanatory Note at the end of the Notice and the enclosures to which it refers contain important additional information.

2. THE LAND AFFECTED

Land at: 14 St Augustine's Road, London NW1 9RN

as shown, for the purposes of identification only, outlined in black on the attached plan.

3. THE BREACH OF PLANNING CONTROL ALLEGED

Without Planning Permission: The unauthorised installation of balustrade and timber planters to allow use of flat roof as a terrace

4. REASONS FOR ISSUING THIS NOTICE:

- It appears to the Council that the above breach of planning control has occurred within the last 4 years.
- 2. The balustrade and timber planters, by reason of their height, detailed design and location are detrimental to the character and appearance of the host building and Camden Square Conservation Area, contrary to policies CS14 (Promoting high quality places and conserving our heritage) of the London Borough of Camden Local Development Framework Core Strategy, and policies DP24 (Securing high quality design), and DP25 (Conserving Camden's heritage) of the London

Borough of Camden Local Development Framework Development Policies.

3. The roof terrace by reason of its position and proximity to neighbouring properties results in harmful overlooking into a rear kitchen and a rear bedroom at numbers 16 and 16a St Augustine's Road and is thereby contrary to policy CS5 (Managing the impact of growth and development) of the London Borough of Camden Local Development Framework Core Strategy and policy DP26 (Managing the impact of development on occupiers and neighbours) of the London Borough of Camden Local Development Framework Development Policies.

The Council do not consider that planning permission should be given because planning conditions could not overcome these problems.

5. WHAT YOU ARE REQUIRED TO DO

Within a period of three months of the Notice taking effect:

- Cease the use of rear upper ground floor roof as a terrace, completely remove the balustrade and timber planters and the resultant material shall be removed from the site
- 2) Make good any damage to the building as a result of the works

6. WHEN THIS NOTICE TAKES EFFECT

This notice takes effect on 2nd July 2015 unless an appeal is made against it beforehand.
