1. **THIS IS A FORMAL NOTICE** which is issued by the Council because it appears to them that there has been a breach of planning control, under Section 171 A (1) (a) of the above Act, at the land described below. They consider that it is expedient to issue this notice, having regard to the provisions of the development plan and to other material planning considerations. The Explanatory Note at the end of the Notice and the enclosures to which it refers contain important additional information.

2. THE LAND AFFECTED

Land at: Heathfield Park Lane 6 Merton Lane N6 6NA

as shown, for the purposes of identification only, outlined in black on the attached plan.

3. THE BREACH OF PLANNING CONTROL ALLEGED

The installation of 4 retractable Bollards to private driveway of dwelling house

4. REASONS FOR ISSUING THIS NOTICE:

- a) It appears to the Council that the above breach of planning control has occurred within the last 4 years for operational development
- b) The bollards are, by virtue of their inappropriate design and material finish, an incongruous feature in the street scene and detract from the character and appearance of the Hampstead Conservation Area contrary to policies Policy CS14 (Promoting High Quality Spaces and Conserving Our Heritage) of the London Borough of Camden Core Strategy 2010 and Policies DP24 (Securing High Quality

Design) and DP25 (Conserving Camden's Heritage) of the London Borough of Camden Development Plan Policies 2010.

c) The position of the bollards in such close proximity to the highway without safe waiting areas may result in vehicles waiting on the carriageway and obstruct traffic flow to the general detriment of highway safety contrary to Policy CS11 (Promoting sustainable and efficient travel) of the London Borough of Camden Core Strategy 2010 and Policy DP21 (Development connecting the highway network) of the London Borough of Camden Development Plan Policies 2010.

The Council do not consider that planning permission should be given because planning conditions could not overcome these problems.

5. WHAT YOU ARE REQUIRED TO DO

Within a period of **two months:** Remove the Bollards and reinstate the drive to match existing surfacing

6. WHEN THIS NOTICE TAKES EFFECT

This notice takes effect on 13 February 2014 unless an appeal is made against it beforehand.


You can appeal against this notice, but any appeal must be received or posted in time to be received by the Secretary of State before 13 February 2014.
