Thank you for your letter of 9 October 2015 notifying us of the application for listed building consent relating to the above site.

These proposals are for the relocating of the Grade II listed Summerhouse at the Kings College London Hampstead Residence as part of a wider redevelopment of the campus. As set out in the supporting information the structure would be carefully dismantled and reinstated within the western courtyard, not far from its current location.

The Summerhouse is currently in very poor condition, and the proposals include the complete refurbishment of the structure in its new location. Providing that that the necessary conservation work will be delivered as part of the scheme, we feel that these proposals are justified and any harm caused to the significance of the Summerhouse in its new location would be outweighed by the heritage benefit of its repair (in accordance with Paragraph 134 of the National Planning Policy Framework).

It is therefore crucial that a full methodology for the deconstructing, relocating and conservation of the Summerhouse is provided before any work is undertaken. We therefore recommend a condition is imposed to this effect. We also strongly advise that a phasing plan for the wider scheme is implemented which requires the delivery of the Summerhouse plans at an early stage in the project. This will ensure that the work will be carried out, and prevent the Summerhouse from deteriorating further and being added to our Heritage at Risk Register.

### Recommendation

We therefore are minded to direct as to the granting of listed building consent. We enclose the draft letter authorising the granting of consent (draft attached) and have referred the case to National Planning Casework Unit. Subject to the Secretary of
