Rear Garden:  
Magnolia: Reduce crown by 15%. Remove one main unsightly rose stem protruding from crown.  
Row of Magnolia Grandiflora: Reduce lateral and sub lateral branches which are extraneous to main crown structures and overhanging lawn by approximately 20% in order to control encroachment whilst preserving screen and natural characteristics of trees.  
Birch: Reduce one minor branch, approximately 5.00cm to 7.50cm at union with main stem, by approximately 1.00m to separate from adjacent birch tree.  
Large Bay: Located in central lawn area. Reduce by approximately 20% as is practicable in order to induce more compact crown growth.  
Griselinia: Trim back to tidy and control encroachment.  
Small Bay: Reduce by approximately 40%.  
Apple: Approximately 5.00m. Fell and remove root-ball as weak specimen and wish to replace with Mulberry.  
Bay: Adjacent to boundary. Reduce by approximately 25%.  
Ivy: Overhanging from neighbouring property. Reduce back to as near to boundary as is practicable.  
Photinia: Reduce height by approximately 30%.  
Bamboo: Trim to tidy. Dig out a separate suitable amount of bamboo for planting project.  
Reasons: General maintenance unless otherwise stated.
