Rear Garden:
2 x Birch: Located in 13 Hampstead Hill Gardens on rear boundary. Approximately 9.00m. Judiciously reduce back lateral and sub lateral branches overhanging 47 by 20-25% selecting suitable secondary leaders in order to ensure crown continuity. Beech and Malus: Approximately 7.00m and 9.00m respectively. Both trees are overhanging and encroaching from 4 Keats Grove. Reduce overhang by 20-25% by selecting suitable secondary growth as mentioned above and to control encroachment.
Laurel Cherry: Located in 6 Keats Grove and is overhanging the garage at the front. Reduce height by 40% to control encroachment.
