Thank you for your tree works applications reference as above.

You have submitted 2 separate applications for various works to trees in the front and rear gardens. Applications reference: 2015/5494/T and 2015/5604/T refer to a Lime tree in the rear garden and another one in the front garden.

However, the description on the application form under application reference: 2015/5573/T is very confusing and needs clarification. You have the 2 conifers in the front garden without works specified and also the Lime tree in the rear garden again but this time as a 30% crown reduction.

Please confirm what type of works you wish to carry out on the 2 conifers in the front garden and whether the Lime tree in the rear has been included in the description by mistake or whether you are applying for the same tree as in application reference: 2015/5494/T but for lesser works.
