The only difference - they will be double-glazed.

The same work has already been done (and permissioned by the Council) for my neighbour above (82 College Place Flat C) two years ago. I am planning to use the same company to produce and install the windows as my neighbour used.

Ideally the works could be scheduled to start mid-December. It will take 5-6 working days to install the windows.

The work will be done by EMU windows, a well-respected company who already installed windows for my neighbor. Thus, I will make sure that we have the same sty of windows. Please see attached supporting document (email) from them.

I am the owner of the flat (lease for c. 102 years), as well as hold 25% share of freehold. The rest of the freeholders (my neighbor above and below) gave me an agreement to proceed with works.
