I act on behalf of Transport for London (TfL) and hereby submit an application for full planning permission for a Cycle Hire docking station consisting of a maximum of 29 docking points and a payment terminal, at the above location.

Cycle Hire was launched in July 2010, and to date almost 40 million journeys have been made. The zone expanded westwards in 2014 to include the London Boroughs of Hammersmith & Fulham and Wandsworth. The scheme is now being introduced into the Queen Elizabeth Olympic Park and there will be a further intensification of the number of docking points in the existing zone.

A docking station comprises the terminal and docking points at one site. Users will hire a cycle from the docking station, use it as desired and return it to either the same or another docking station. The terminal is required to secure and release the cycles, for payment of subscription fees and user tariffs, and to provide information about the area including the location of other docking stations and way-finding mapping (which has deemed advertising consent).

The application has been made on the Planning Portal. It consists of:
