# LISTED BUILDING ENFORCEMENT NOTICE

1. **THIS IS A FORMAL NOTICE**, which is issued by the Council being the Local Planning Authority for the purposes of Section 38 of the above Act because it appears to them that there has been a contravention of Section 8 of the Act, in respect of the building within a conservation area described below. The Council considers it necessary to issue this notice for the reasons set out in paragraph 4 below.

# 2. THE LISTED BUILDING.

Land at: 15 Greville Place, London NW6 5JE

as shown, for the purposes of identification only, outlined in black on the attached plan.

# 3. THE CONTRAVENTION ALLEGED.

Without listed building consent: The installation of two satellite dishes on top of the roof and one large satellite dish mounted on a pole in the rear garden

# 4. REASONS FOR ISSUING THIS NOTICE

- a) The work outlined above has been carried out to this Grade II listed building without the benefit of Listed Building Consent.
- b) The authorised works to the Grade II listed building are considered to have a detrimental impact on the special architectural, historic interest and setting of the listed building and fail to preserve or enhance the appearance of the character or appearance of the St. Johns Conservation area, and that if allowed, would be harmful and set an unwelcome precedent for alterations to listed buildings contrary to policies CS14 (Promoting high quality places and conserving our heritage) of the London Borough of Camden Local Development Framework Core Strategy and policies DP24 (Securing high quality

design) and DP25 (Conserving Camden's heritage) of the London Borough of Camden Local Development Framework Development Policies.

# 5. WHAT YOU ARE REQUIRED TO DO

Within a period of **one month** of the Notice taking effect:

Completely remove the 2 x satellite dishes at roof level and the 1 X satellite dish, pole and any fixings in the rear garden and make good any damages to the building.

# 6. WHEN THIS NOTICE TAKES EFFECT

This notice takes effect on **23 December 2015** unless an appeal is made against it beforehand.


