


UPPER WOBURN PLACE ELEVATION : AS EXISTING



- PROPOSED CANOPY CONSTRUCTION TO BE PPC STEEL/ ② ALUMINIUM FRAME AT 5° PITCH, COLOUR TO MATCH EXISTING IRONWORK WITH NOM 32mm THICK PILKINGTON GLAZING SYSTEM WITH LIGHT SAND BLASTING, OR SIMILAR




Clear Silicone Bead both sides of Glass


TYPICAL FRAME-LESS GLAZED BALUSTRADE 1:5
