Dear Ian Gracie

I wish to object to the application for the enlargement of the house at 35 Camden Mews. The increased bulk and loss of any garden will be out of character in this conservation area.

I specifically object strongly to the extra storey because:

- this increased height would block light from surrounding houses and gardens.
- the windows in the new higher storey would give on to neighbouring properties and seriously affect their privacy
- the bulk of the new storey would block sight lines and give a claustrophobic feel to neighbouring properties
- were this development to take place it could act as a precedent to other similar enlargements resulting in a serious deterioration in the quality of life of those living in the mews and those with houses backing onto it.

I do hope that the council planning department will decide in this case that the increase in space and possible property value for one person should not be more important than the quality of life and amenity of the many neighbouring people.

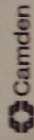
I object to this application for permission to demolish a 2 storey mews house and replace it with a 3 storey house also occupying the garden,
