

56-58 FREDERICK STREET, LONDON WC1X 0ND

DESIGN, ACCESS HERITAGE STATEMENT

The Planning and Listed Building applications relate to the basement flats (56A&56B), the first and the second floors lateral flats in 56-58 Frederick Street. Works to the ground floor flat (56C) were carried out in Phase 1.





1. Site Analysis

56-58 Fredrick Street are five-storey terrace properties (including basements and attic) built during the first half of the 19th Century (c.1830) by Thomas Cubitt. They are Grade II listed and in the Bloomsbury Conservation Area.

Extracts from 'Bloomsbury Conservation Area Appraisal and Management Strategy' – Adopted 18 April 2011:

Calthorpe Street/Frederick Street.

This sub area is situated on the eastern edge of the Bloomsbury Conservation Area, east of Gray's Inn Road, and abuts the boundary with the London Borough of Islington. It comprises an area of mainly terraced housing built on the Swinton and Calthorpe Estates to the east of Gray's Inn Road, an historic route dating back at least to Medieval times. It is one of the few parts of the Conservation Area that has a noticeable fall from west to east, being on the west side of King's Cross Road which follows the valley of the now culverted River Fleet. The northernmost part around Swinton Street was developed in the late 18th century following the construction of New Road (now Euston Road) and a small suburb to the north of this area around Battle Bridge. The remainder of the area was developed over the period 1820 to 1850 by the builder Thomas Cubitt who had his yard in this area. A notable pattern is the progression of development from west to east and the gradual variation in the detailed treatment of the frontages. In the 1860s the excavation for the new Metropolitan Railway cutting bisected Swinton Street and Acton Street towards their eastern end.

Most of the buildings in this area date from the 1820s to the 1840s, and were designed and built by Thomas and William Cubitt. 19th century development progressed from west to east, although there have been some areas of post-war redevelopment. There is slightly greater use of stucco render in these quieter streets. There is generally a grander, classical approach to the overall composition of elevations, which boast pilasters, pediments and projections, emphasising the design of the terrace as a single composition (particularly evident on Frederick Street). Several terraces in this area have entrance porticos at street level giving greater architectural significance, a feature not seen in the streets to the north.

The properties are part of a portfolio of properties acquired by Community Housing Association in the 1970's in Frederick Street, Ampton Place and Ampton Street. 56-58 Frederick Street was converted into flats during the early/mid-1980s.

2. Development Objectives

One Housing Group is intending to carry out a series of repairs and improvements throughout the majority of their properties in the immediate vicinity (i.e. Frederick Street, Ampton Street and Ampton Place). Generally, the works will consist of the essential renewal of the services (mechanical and electrical installations), kitchen fitting and bathrooms together with all other necessary repairs. Improvements to the internal layouts of the maisonettes, flats and bedsits may also be proposed on a property-by-property, unit-by-unit basis.



56+58 Frederick Street are among several properties planned for upgrading within the fifth phase.

3. Design Solution and impact on heritage assets

The communal entrance hall of no.56 is shared with the basement flats in 56 and 58 (numbered 56B and 56A respectively). The communal entrance door to 58 provides access to the two lateral flats at first and second floor levels.

The layout of the flats is arranged as follows:

- the basement flat on the left hand side (56A) contains a bedroom and a shower room in the front, a living/dining room with a separate kitchen in the back; the rear garden is accessed via a glazed door in the kitchen.
- the basement flat on the right hand side (56B) contains a bedroom in the front, an internal bathroom and a kitchen/living/dining room in the back; the rear garden is accessed via glazed doors in the living room.
- the first and the second floor flats contain a living room and a bedroom in the front half of the buildings, a kitchen, bathroom and bedroom in the rear.
- the attic is only accessible through a roof hatch in the second floor flat.

Planning consent and Listed Building consent are being sought for the following alterations (in addition to other minor alterations identified on the submitted drawings):

- new double glazed timber doors at front and rear in basement flats.
- new panelled door to basement front area in Flat 56B.
- new double glazed casement window to back extension in Flat 56B.
- new double glazed casement windows in existing dormers in attic floor.
- introduction of conservation rooflights to enable visual inspection of front roof and gutter, which is otherwise inaccessible.
- a roof-mounted communal satellite dish is also proposed to the main roof, rear slope.

The proposed alterations are minor and very discreet – they will not be noticeable from the street and will therefore have no adverse impact on the listed building. They do not harm the building nor do they affect any original features, they are largely reversible and will positively contribute to the stock of housing in the area by improving the quality and standard of accommodation available.

4. Access

There are no proposed changes affecting the access arrangements.

5. Affect on neighbours

The proposals will have no affect on neighbours.



6. Landscaping

The proposals do not include any changes to landscaping.
