ENFORCEMENT NOTICE

OF 1-3 Flask Walk
London
NW3 1HJ

1. **THIS IS A FORMAL NOTICE** which is issued by the Council because it appears to them that there has been a breach of planning control, under Section 171 A (1) (a) of the above Act, at the land described below. They consider that it is expedient to issue this notice, having regard to the provisions of the development plan and to other material planning considerations. The Explanatory Note at the end of the Notice and the enclosures to which it refers contain important additional information.

2. **THE LAND AFFECTED**

Land at: 1-3 Flask Walk, London NW3 1HJ

as shown, for the purposes of identification only, outlined in black on the attached plan.

3. **THE BREACH OF PLANNING CONTROL ALLEGED**

Without Planning Permission: The erection of a new roof at the rear of the property

4. **REASONS FOR ISSUING THIS NOTICE:**

- a) It appears to the Council that the above breach of planning control has occurred within the last 4 years.
- b) The larger bulk, increased prominence, poor materials and modern design of the new roof all detract from the special architectural and historic character of this listed building, neighbouring listed buildings, the streetscene and the Hampstead Conservation Area in general contrary to policies CS14-Promoting High Quality Places, DP24-Securing high quality design and DP25-Conserving Camden's heritage.

Council reference: EN15/0463

- a) The enlarged roof causes loss of amenity through loss of light to neighbouring properties contrary to policies CS5-Managing the impact of growth and development and DP26-Managing the impact of development on occupiers and neighbours.

The Council do not consider that planning permission should be given because planning conditions could not overcome these problems.

5. WHAT YOU ARE REQUIRED TO DO

Within a period of **six months** of the Notice taking effect:

Remove the new roof form and reinstate the original roof in terms of design, profile and materials.

6. WHEN THIS NOTICE TAKES EFFECT

This notice takes effect on **31 December 2015** unless an appeal is made against it beforehand.

Note Pursuant to Regulation 5 of the Town and Country (Enforcement Notices and Appeals) (England) Regulations 2002

If you appeal against the notice on Ground (a) "That planning permission should be granted for what is alleged in the enforcement notice, or that the condition which is alleged not to have been complied with should be discharged" there is a fee payable under Regulation 10 of the Town and Country Planning (Fees for Applications, Deemed Applications, Requests and Site Visits) (England) Regulations 2012/No.2920 for the deemed application for the planning permission for the development alleged to be in breach of planning control in the enforcement notice.

The fee is payable twice to the "London Borough of Camden", as the Local Planning Authority.

You can appeal against this notice, but any appeal must be received or posted in time to be received by the Secretary of State before **31 December 2015**.

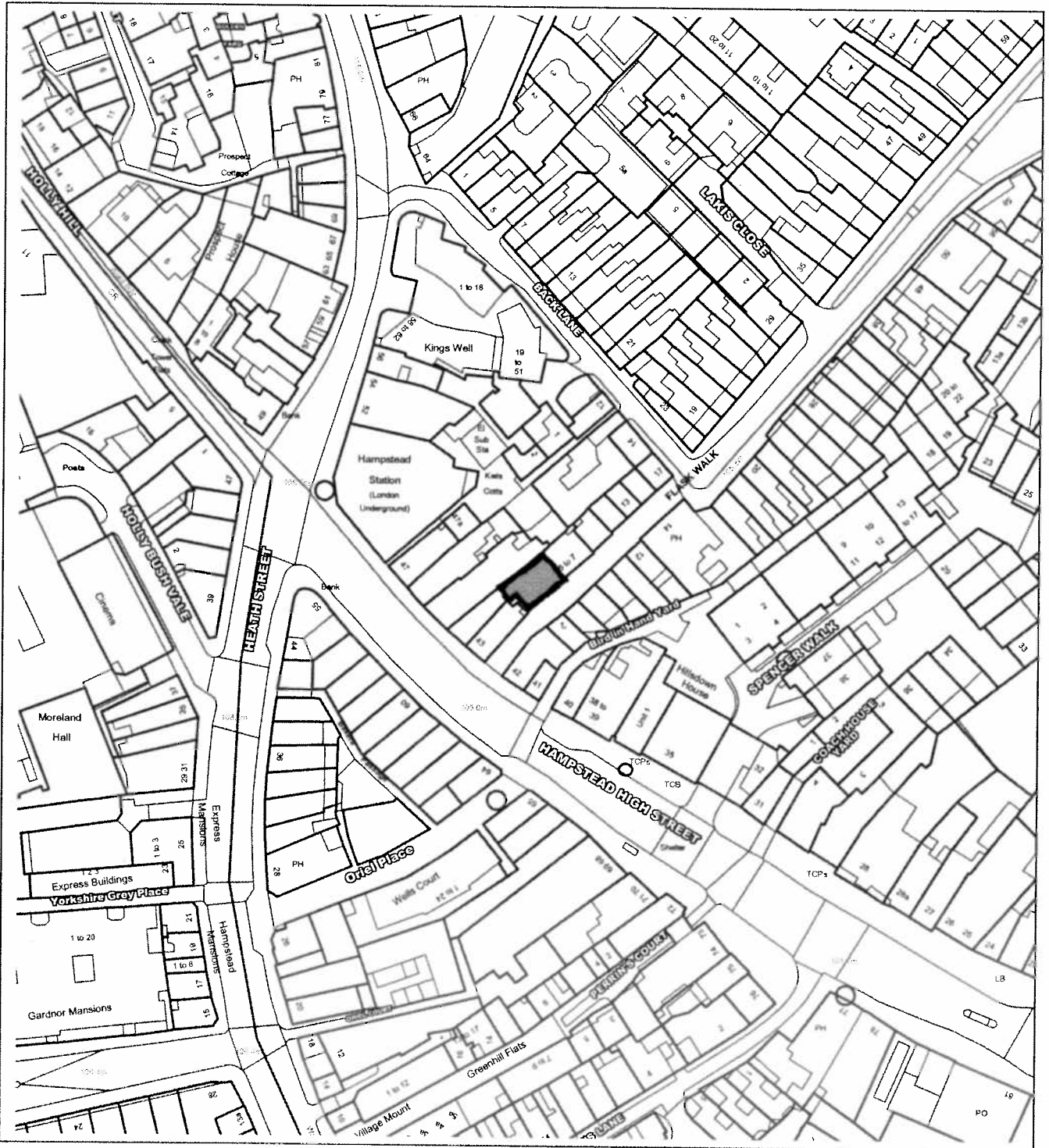
