2 x Lime - Approximately 13.00m. Condition fair. Reduce lateral and sub-lateral branches by 25%. Reduce crown height by approximately 20% back to previous reduction points whilst preserving a suitable amount of furnishing growth in order to ensure crown continuity. Thin crown density by approximately 20-25%. Remove dead wood and broken branches. Reasons - to help reduce potential hazards, abate nuisance from low overhanging branches, increase light levels and help curtail the trees sphere of influence in relation to walls and buildings whilst preserving tree health, natural characteristics and aesthetic value.
