DECISION

Proposal:

Replacement of all existing single-glazed timber windows with double glazed timber windows, installation of 1 rooflight to rear and new double-glazed timber sliding door to ground floor rear.

The Council has considered your application and decided to grant permission subject to the following condition(s):

Condition(s) and Reason(s):

The development hereby permitted must be begun not later than the end of three years from the date of this permission.

Reason: In order to comply with the provisions of Section 91 of the Town and Country Planning Act 1990 (as amended).



All new external work shall be carried out in materials that resemble, as closely as possible, in colour and texture those of the existing building, unless otherwise specified in the approved application.

Reason: To safeguard the appearance of the premises and the character of the immediate area in accordance with the requirements of policy CS14 of the London Borough of Camden Local Development Framework Core Strategy and policies DP24 and DP25 of the London Borough of Camden Local Development Framework Development Policies.

The development hereby permitted shall be carried out in accordance with the following approved plans: (10)010-P1, (10)100-P1, (10)101-P1, (10)300-P2, (10)301-P2, (21)700-P1, (21)701-P1 and Design & Access Statement Rev 151118.

Reason: For the avoidance of doubt and in the interest of proper planning.

Informative(s):

1 Reasons for granting permission:

The proposed works are considered minor alterations that would not harm the character or appearance of the host building, the surrounding mews, or the wider Camden Square Conservation Area. The existing single glazed timber windows and doors at front and rear first and second floor level would be replaced with double glazed timber framed windows. They would match the existing windows in terms of size, style, material and opening method and are therefore considered acceptable. The new rooflight to the rear roofslope would measure 1.4m x 1.4m and would not project more than 10cm from the roofslope. Rooflights are a characteristic feature of the surrounding mews and the proposal would therefore not harm the appearance of the host building or surrounding terrace. At ground floor level, the existing single-glazed timber doors and panels would be replaced with double glazed timber framed doors. They would be fitted into the existing aperture and would be a sympathetic alteration.

The alterations are not considered to result in any harm to neighbouring occupants in terms of a loss of privacy, daylight or outlook.

Two objections and one comment have been received and duly taken into account prior to making this decision. The site's planning history and relevant appeal decisions were taken into account when coming to this decision.

Special attention has been paid to the desirability of preserving or enhancing the character or appearance of the conservation area, under s.72 of the Listed Buildings and Conservation Areas Act 1990 as amended by the Enterprise and Regulatory Reform Act (ERR) 2013.

As such, the proposed development is in general accordance with policies CS5

and CS14 of the London Borough of Camden Local Development Framework Core Strategy and policies DP24, DP25, and DP26 of the London Borough of Camden Local Development Framework Development Policies. The proposed development also accords with policies 7.4, 7.6 and 7.11 of The London Plan March 2015, consolidated with alterations since 2011 and paragraphs 14, 17, 56 -68 and 126-141 of the National Planning Policy Framework.

- Noise from demolition and construction works is subject to control under the Control of Pollution Act 1974. You must carry out any building works that can be heard at the boundary of the site only between 08.00 and 18.00 hours Monday to Friday and 08.00 to 13.00 on Saturday and not at all on Sundays and Public Holidays. You are advised to consult the Council's Compliance and Enforcement team [Regulatory Services], Camden Town Hall, Argyle Street, WC1H 8EQ (Tel. No. 020 7974 4444 or on the website http://www.camden.gov.uk/ccm/content/contacts/council-contacts/environment/contact-the-environmental-health-team.en or seek prior approval under Section 61 of the Act if you anticipate any difficulty in carrying out construction other than within the hours stated above.
- Your proposals may be subject to control under the Building Regulations and/or the London Buildings Acts which cover aspects including fire and emergency escape, access and facilities for people with disabilities and sound insulation between dwellings. You are advised to consult the Council's Building Control Service, Camden Town Hall, Argyle Street WC1H 8EQ, (tel: 020-7974 6941).
