LISTED BUILDING ENFORCEMENT NOTICE

OF 143a Prince of Wales Road London NW5 3PU

1. **THIS IS A FORMAL NOTICE**, which is issued by the Council being the Local Planning Authority for the purposes of Section 38 of the above Act because it appears to them that there has been a contravention of Section 8 of the Act, in respect of the building within a conservation area described below. The Council considers it necessary to issue this notice for the reasons set out in paragraph 4 below.

2. THE LISTED BUILDING.

Land at: 143a Prince of Wales Road, London NW5 3PU as shown, for the purposes of identification only, outlined in black on the attached plan.

THE CONTRAVENTION ALLEGED.

Without listed building consent: Unauthorised demolition of the chimney breast in rear ground floor room

4. REASONS FOR ISSUING THIS NOTICE

- a) The work outlined above has been carried out to this Grade II listed building without the benefit of Listed Building Consent.
- b) The demolition of the chimney breast on the ground floor of this Grade II listed building adversely affects its special architectural and historic interest by the alteration of the plan form, thereby impacting room proportion and volume, and causing harm to the designated heritage asset's significance, contrary to policies CS5 and CS14 of the London Borough of Camden Local Development Framework Core Strategy, and policies DP24, DP25 of the London Borough of Camden Local Development Framework Development Policies. The unauthorised works also fails to accord with policies 7.4, 7.6 and 7.8 of the London Plan March 2015, consolidated with alterations since 2011; and

paragraphs 14, 17, 56-66 and 126 - 141 of the National Planning Policy Framework.

5. WHAT YOU ARE REQUIRED TO DO

Within a period of three months of the Notice taking effect:

- 1. Completely rebuild the chimney breast to be fully functioning, using a traditional construction method, to its original height, length and depth prior to demolition using reclaimed Imperial size London stock bricks to a finished depth of 375 mm being approximately two Imperial size bricks.
- 2. The chimney breast shall be finished with a traditional lime plaster finish to accurately replicate the age, style and status of the building.
- 3. Remove all structural interventions (including brackets) required as a result of demolition of the chimney breast once it has been rebuilt.

6. WHEN THIS NOTICE TAKES EFFECT

This notice takes effect on **6 January 2016**, unless an appeal is made against it beforehand.


