Details of sustainable urban drainage strategy, hard and soft landscaping, confirmation of suitably qualified chartered engineer, and retention and protection of trees required by conditions 4, 5, 8, and 10 of planning permission 2012/3861/P dated 18 September 2013 for the excavation of basement beneath front garden and double-basement beneath rear garden, erection of 2-storey side extension at lower ground and ground floor level and rear extension at ground floor level all in connection with existing dwellinghouse (Class C3). 1 Details of sustainable urban drainage strategy - Condition 4 A Sustainable Drainage Strategy and Drainage Calculations details have been submitted and reviewed by the council's sustainability section and are considered sufficient to discharge the requirements of Condition 4.

Details of hard and soft landscaping - Condition 5

The landscaping proposes a variety of paved and planted areas and boundary treatments, including permeable paving, lawns, hedges and shrubs. The details will enhance the visual appearance of the house and streetscene, enhance biodiversity of the site and will prevent surface water flooding. As such they are considered sufficient to discharge the requirements of Condition 5.

Details of suitably qualified chartered engineer, Condition 8 The submitted information confirms that chartered structural engineers have been appointed to oversee the basement construction works. The engineers have the relevant CEng and CGeoL qualifications which comply with the requirements set out in Camden Planning Guidance 4 (CPG4 - Basement and lightwells). The details submitted are therefore sufficient to discharge condition 8.

Details of retention and protection of trees - Condition 10 The tree protection plan submitted is considered to be sufficient to demonstrate that the trees to be retained will be adequately protected during construction work and are sufficient to discharge condition 10.

Special attention has been paid to the desirability of preserving or enhancing the character or appearance of the conservation area under s.72 of the Planning (Listed Buildings and Conservation Areas) Act 1990 as amended by the Enterprise and Regulatory Reform Act (ERR) 2013.

As such the proposed development is in general accordance with policy CS14, CS15 and CS16 of the London Borough of Camden Local Development Framework Core Strategy and policies DP22, DP23, DP24, DP25 and DP27 of the London Borough of Camden Local Development Framework. The proposal also accords with policies 7.4, 7.8 and 7.21 of the London Plan March 2015, consolidated with alterations since 2011 and paragraphs 56-68 and 126-141 of the National Planning Policy Framework.

2 You are advised that all conditions relating to planning permission consent 2012/3861/P dated 18 September 2013 which need details to be submitted, have been approved
