Phase 1 and 2 Extent of Works

Proposed Trees:

- Semi-mature standard form specimen tree planting within public realm including Agar Grove TPO strengthening
- Multi-stemmed flowering tree
- Pollarded specimen trees within swale
- Semi-mature standard form flowering or fruiting trees
- Semi-mature specimen multi-stemmed tree
- Standard form fruiting tree

Proposed Climbing Plants: (Refer also to relevant Plant Mix Bed Refs within Plant Schedules)

- Climbing Plant - refer to annotation and plant schedules for numbers and species

Plant Bed Mixes:

Public Realm Planting:

- Beds AG1-AG6: Ground cover shrub planting to Agar Grove. Ferns and sedge species groups to be included within the raised planter beneath existing tree Ref. T043. Note: Hand dug pit planting within the RPZ of existing trees.
- Beds GS1 to GS7: Green Street evergreen shrub plinth and hedge with ornamental grass and herbaceous infill panels.
- Bed HE-1: Hedgerow planting
- LG1 to LG3: Lulworth Gardens West perimeter planting of evergreen hedge with ornamental grass and herbaceous mix with climbing plants to metalwork trellis T2.
- SW1 to SW4: Swale wet-dry habitat planting to Lulworth Gardens perimeter.

Public Realm Lawn Areas:

- Agar Place Raised Lawn: Species rich turf with bulb planting.
- Lulworth Gardens Activity Lawn: Amenity turf lawn.

Communal Courtyards:

- Beds A1.1 to A1.5: Raised planter beds with shade tolerant semi-ornamental grasses, ferns and herbaceous mix.
- Beds H2.1 to H2.8 and FGH1.1 to FGH1.5: Semi-ornamental grasses and herbaceous mix including climbing plants to building elevations, locations as shown.
- Beds: SP1 to SP4: Semi-ornamental grasses and herbaceous mix associated with specimen tree planting.
- Beds A2.1 to A2.5: Plot A Courtyard, native species woodland edge and ground flora to southern boundary and below existing trees.

Residential Frontage Privacy Strips:

- Beds A3.1 to A3.8 and H1.1 to H1.10: Shade tolerant herbaceous, ferns, grasses and climbing plants
- Beds G1.1 to G1.10: Ornamental herbaceous, ferns, grasses and climbing plants
- Beds F1.1 F1.7: Rain Gardens wet-dry habitat species

Private Residential Gardens:

- Plot A Gardens: Ornamental turf lawn.

Roof Gardens:

- Brown roof: Brownfield site habitat to include circa 30% planting cover.
- Intensive Green Roof - to form Acid Grassland Habitat.
- Lightweight roof structures with extensive Green Roof e.g. Sedum spp mat.
- Amenity roof gardens (private or communal). Planting to be contained within planters or pot planting.

Refer to Roof Gardens Plant Schedules for proposed species mix and Architects drawings for extents of green and brown roof areas.
