Silver Birch (Betula pendula) (T2) (Approximate height 10m)	Rear garden right hand boundary	Crown reduce by removing 3m from height. Crown reduce by removing 1-2m from sides to allow more light to house.
Lime (Tilia cordata) (T3) (Approximate height 11m)	Rear garden rear boundary left hand side	Pollard to oldest pollard points to leave a 5m tall tree to remove all dieback and dead branches
Lime (Tilia cordata) (T4) (Approximate height 13m)	Rear garden rear boundary right hand side	Crown reduce by removing 3-4m from height. Crown reduce by removing 1-2.5m from sides as part of continued maintenance
