Going through your Heritage Statement, the replacement of external shutters with internal ones is mentioned in paragraph 5.1 and 5.2 on page 16.

If the shutters are not to be relocated internally – although all in situ have to be removed for being in place unlawfully – you will need to amend both paragraphs by removing the entry referring the internal installation of the roller shutters.

You need to amend the information on page 16 of your Heritage Statement. Alternatively, I can delete these for you but do need you to confirm you agree to this in writing.

I must again bring to your attention that the installation of internal roller shutters, should you wish to do so at a later date, will require listed building consent. Failure to gain the property permission may lead to a new enforcement case being opened and the necessary steps taken to have the situation either corrected or formalised.
