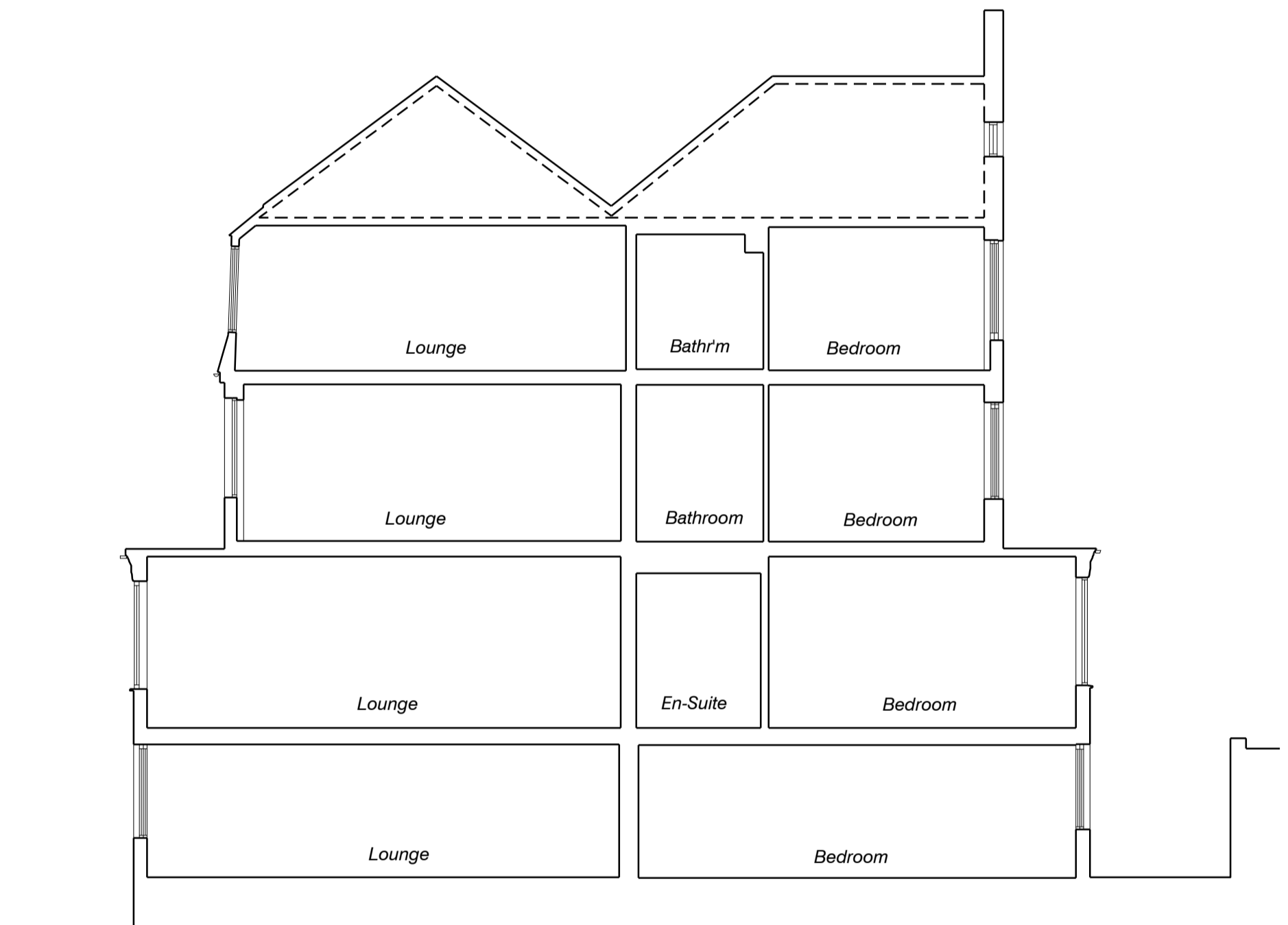
SECTION BB - AS PROPOSED

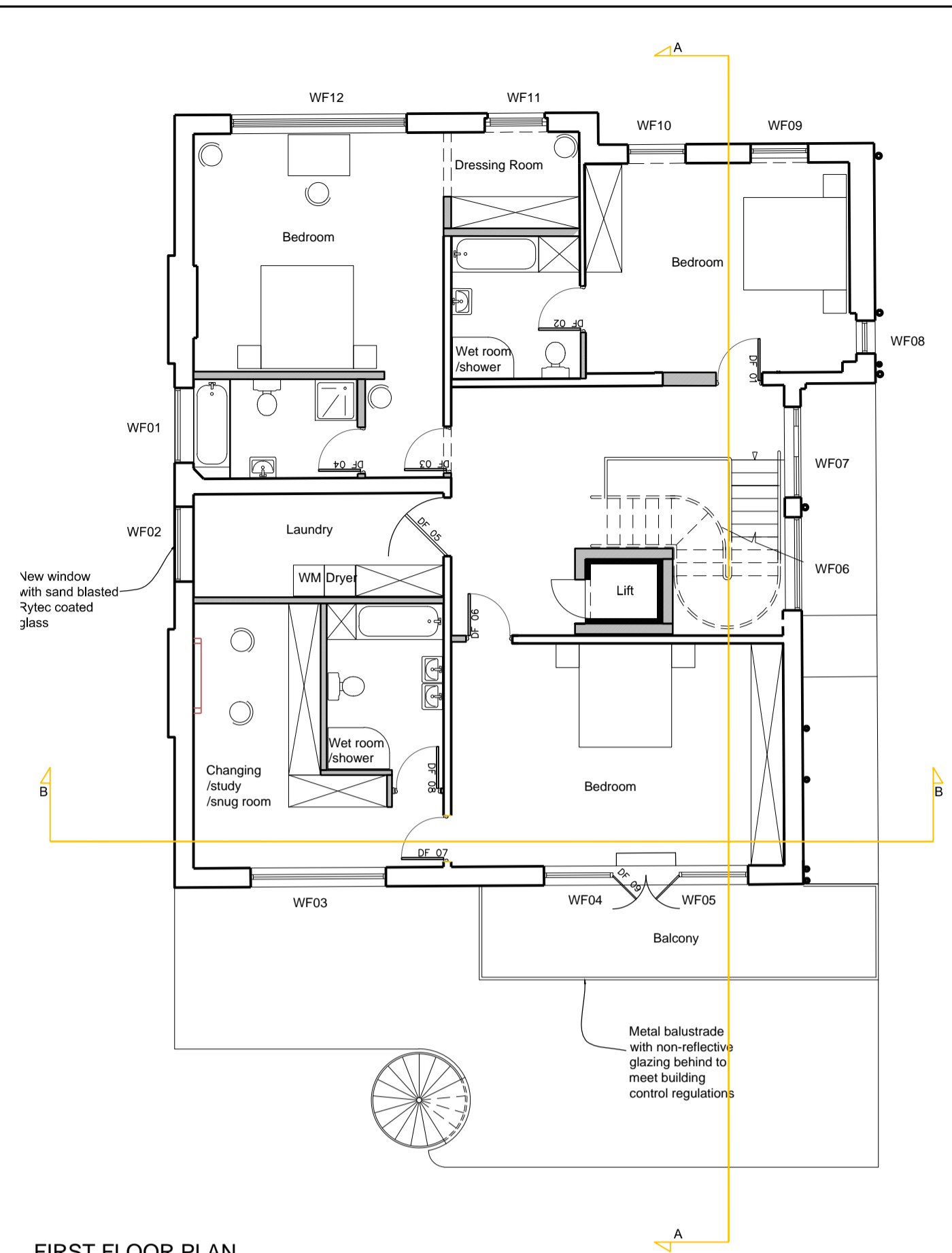
LOWER GROUND FLOOR



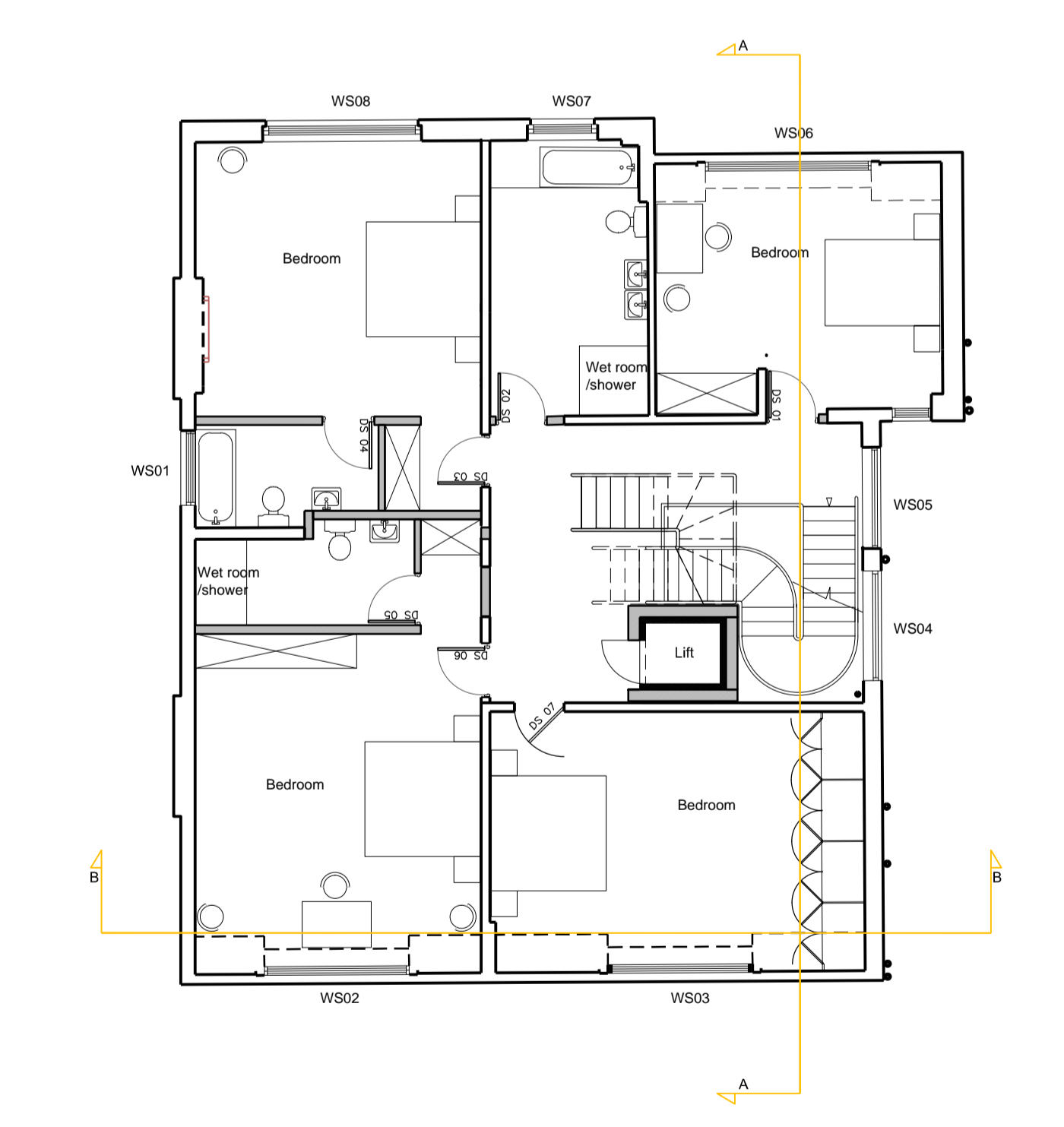
