One branch is damaged and in danger of falling into the No. 5 garden -- No 5 owner has asked us to deal with this.

An arborist has recommended: "Reduce to pollard points. Re Pollard".

T3: Black Poplar tree, 22m tall, 1.2m diameter. Located in the garden of 47 Belsize Square, owned by Gemma Moreno.

An arborist has recommended: "Reduce to previous points + remove pegs. Re Pollard".
