The Purpose of this Document

This document has been prepared on behalf of Theatre Tracks Limited for the extension to their existing planning application, for a temporary theatre venue, which provides a venue for a theatrical production of The Railway Children and potential other shows. The purpose is to show the additional back of house tent structure which is used on the site which is located at Zone A, Goods Way, King's Cross Central, London N1C 4UR and to extend the current planning application by twenty four months to the end of January 2018.

This statement forms part of the application for planning permission for these facilities.

Temporary Structure – Back of house storage space

A temporary marquee structure, measuring 12m wide by 15m long (to a roof apex of 7m) has been installed on the site for additional storage and working space. It can be seen on location plan (attached). The following photos show the temporary structure in situ, at the southern end of the site.
