The mansard roof and the fenestration in the approved application were introduced to respect the adjoining house, 23 Hampstead Hill Gardens. These features are now being revised and the opportunity should be taken to detach/separate the two houses.</li> <li>2. The top flat of 23 Hampstead Hill Gardens has views over the roof of 23A. The approved new 23A is higher and wider than existing 23A so these views are already diminished. The 12 Solar Photovoltaics will "be hidden from view behind the raised parapet" from the street but will be in full view of the windows of the top flat of 23 Hampstead Hill Gardens. The flat roof should be a living green roof with access only for maintenance.</li> <li>3. I'm pleased that the impractical hedge which lined the light well and the passage between 23A and 23 Hampstead Hill Gardens is now redundant and should be removed.</li> <li>4. I'm also pleased that the "corten" fence on the rear boundary of 23 and 23A Hampstead Hill Gardens is being replaced and that the height of the boundary fence has been modified.
