- The tree works are proposed to stop the influence of the tree(s) on the soil below building foundation level and provide long term stability.
- Estimated costs of repair to the building are £50,000.00 if the influence of the tree(s) remain and £11,205.00 if the proposed tree works are allowed to proceed. Granting permission will limit these costs. In the event of a refusal we, or our clients, will seek to secure compensation for the additional costs incurred through Section 202 (e).
- Should the tree/s remain the total cost of repairs will be the Superstructural repairs + Alternative method of repairs = £61,205.00
- It is the expert opinion of both the case engineer and arboriculturalist that on the balance of probabilities the supporting information demonstrates the influence of the tree(s).
- Note: Further monitoring results may be submitted if these become available during the course of this application.
