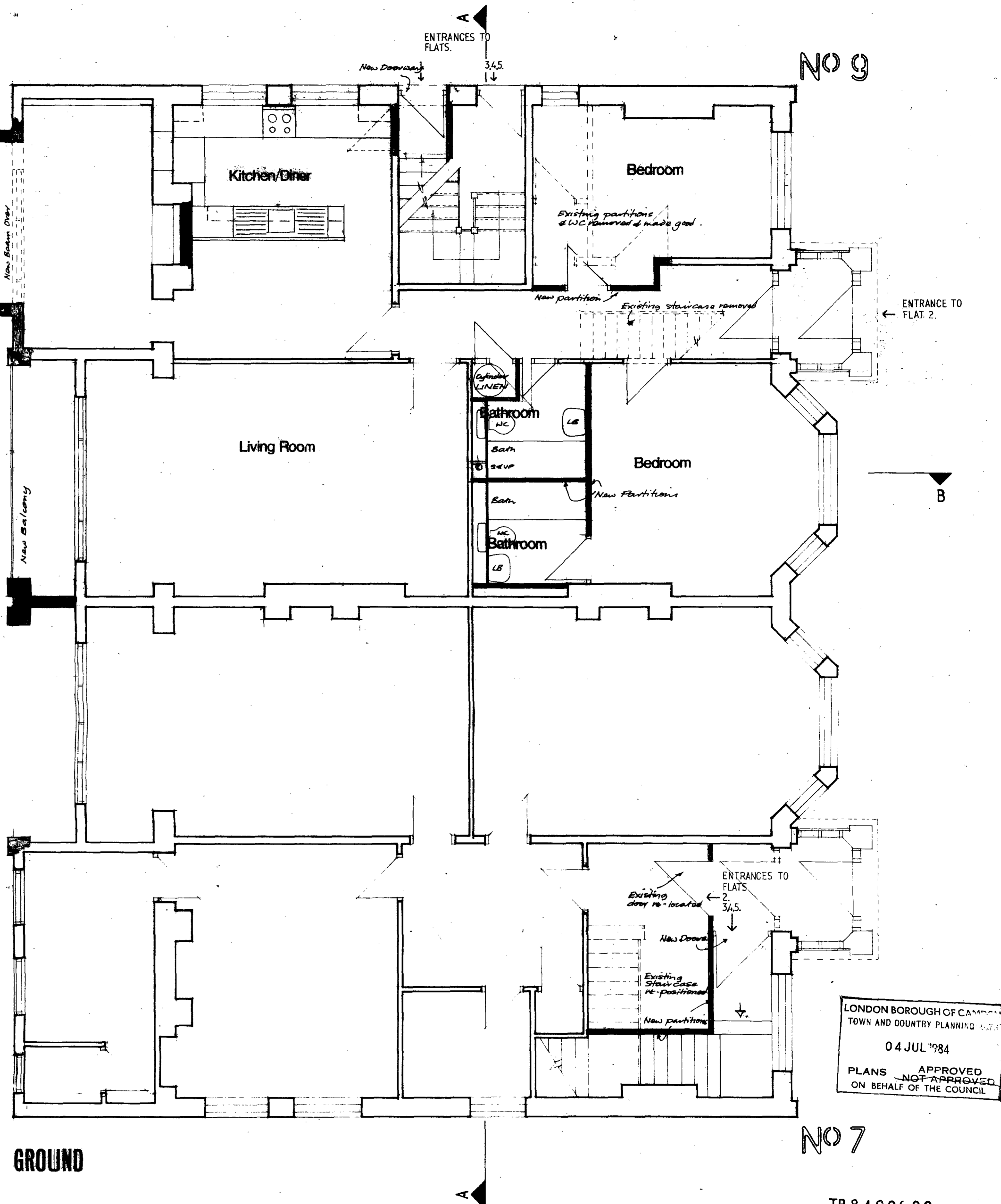
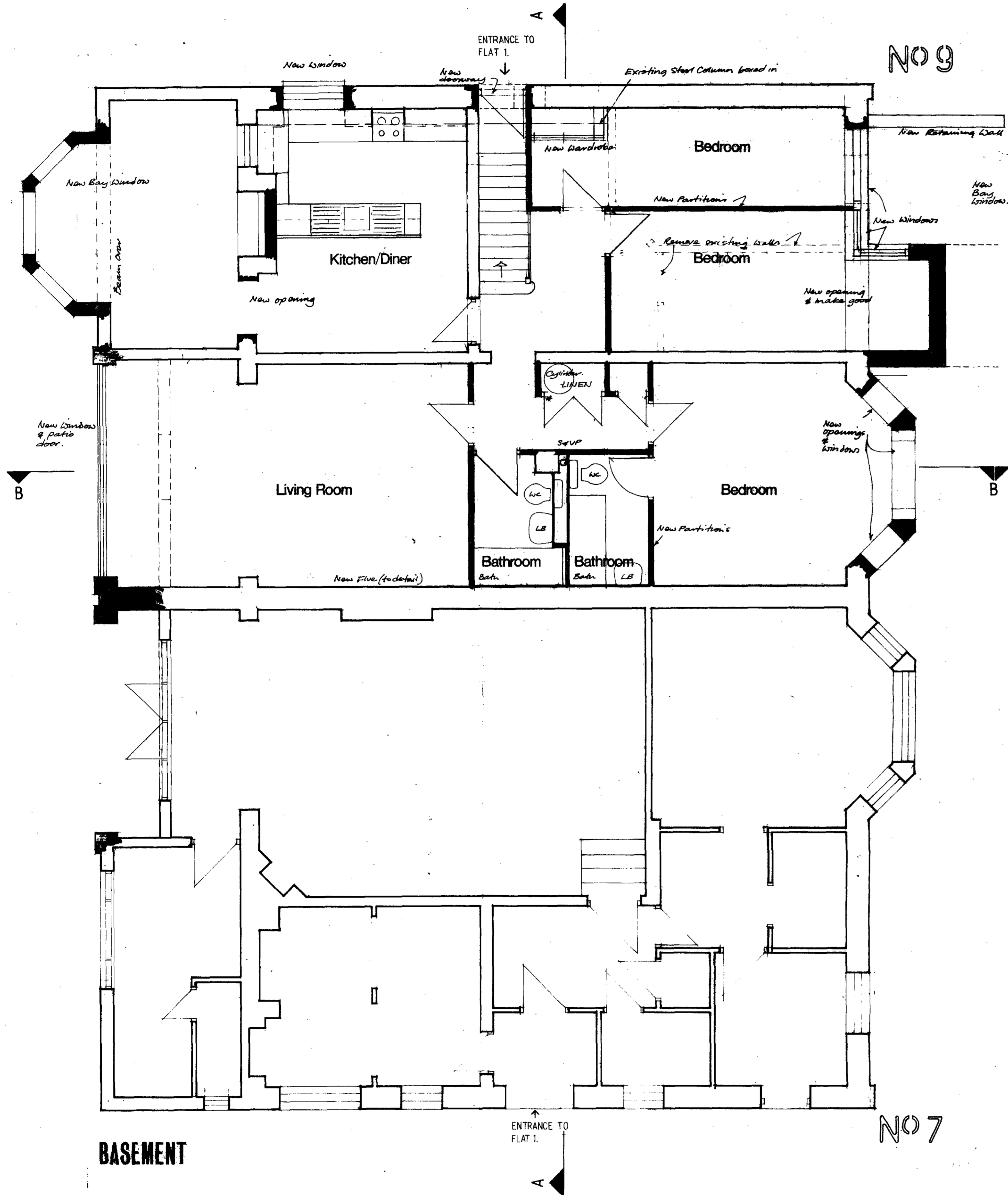
Floor Plans

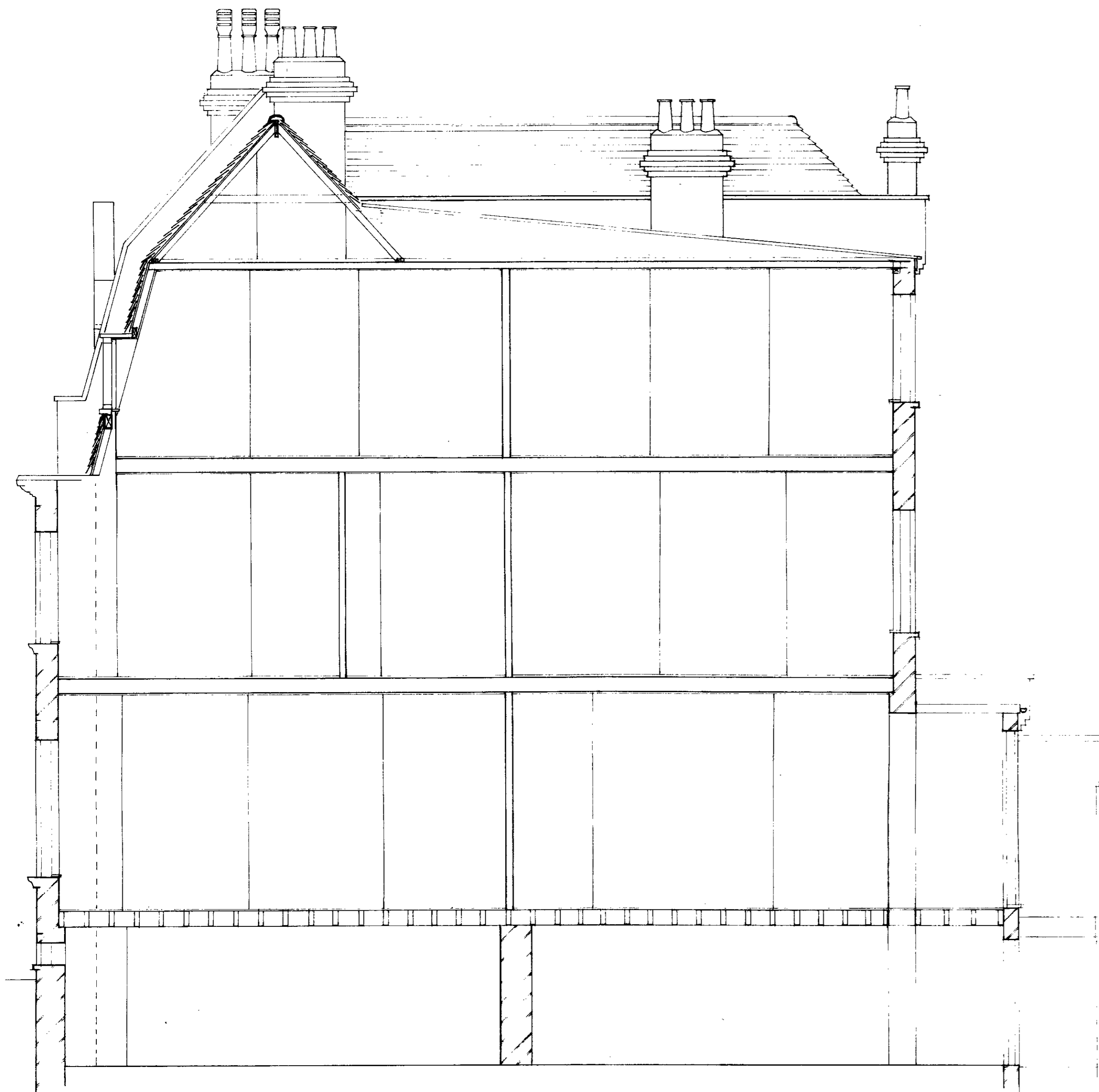

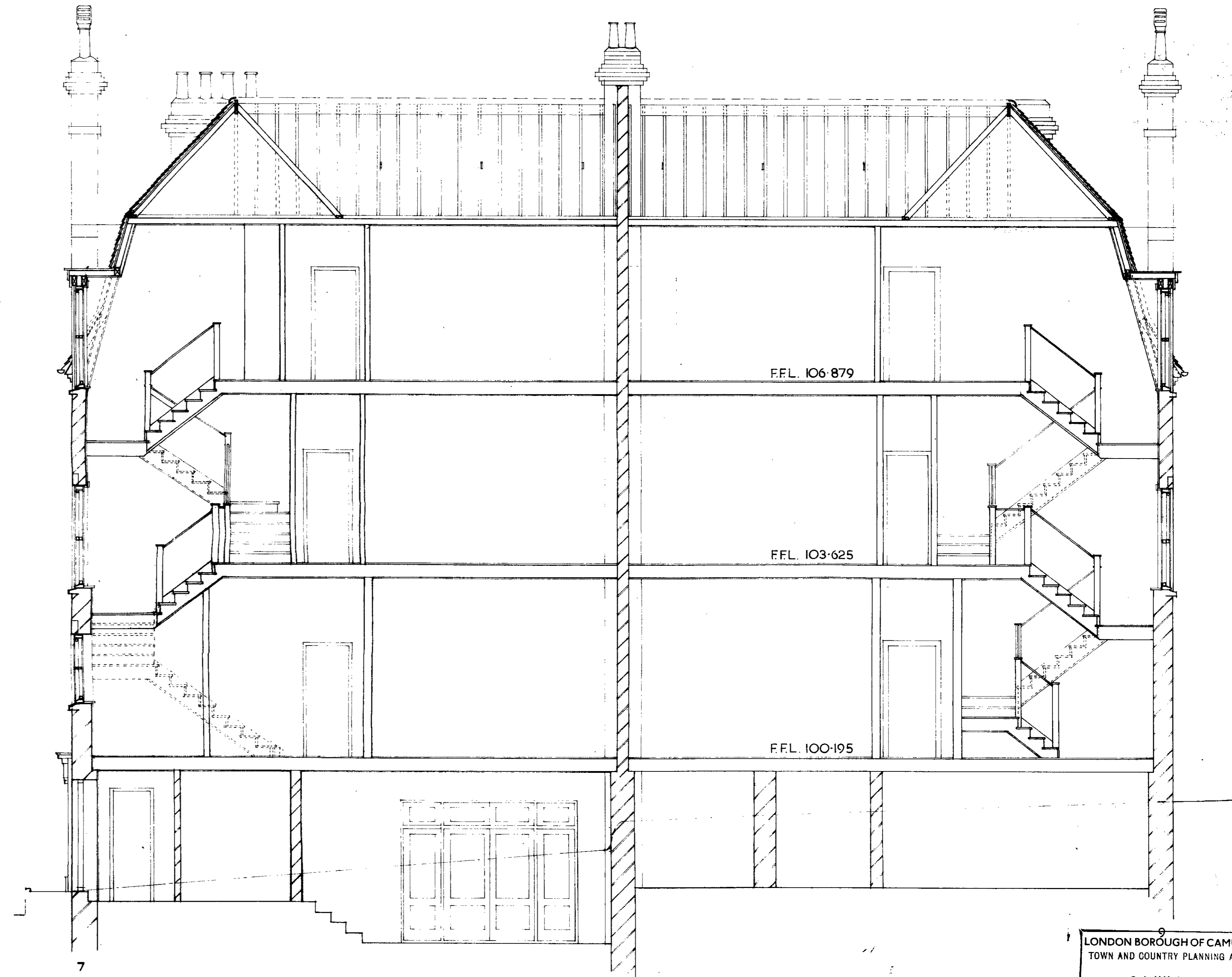

EXISTING SECTION BB

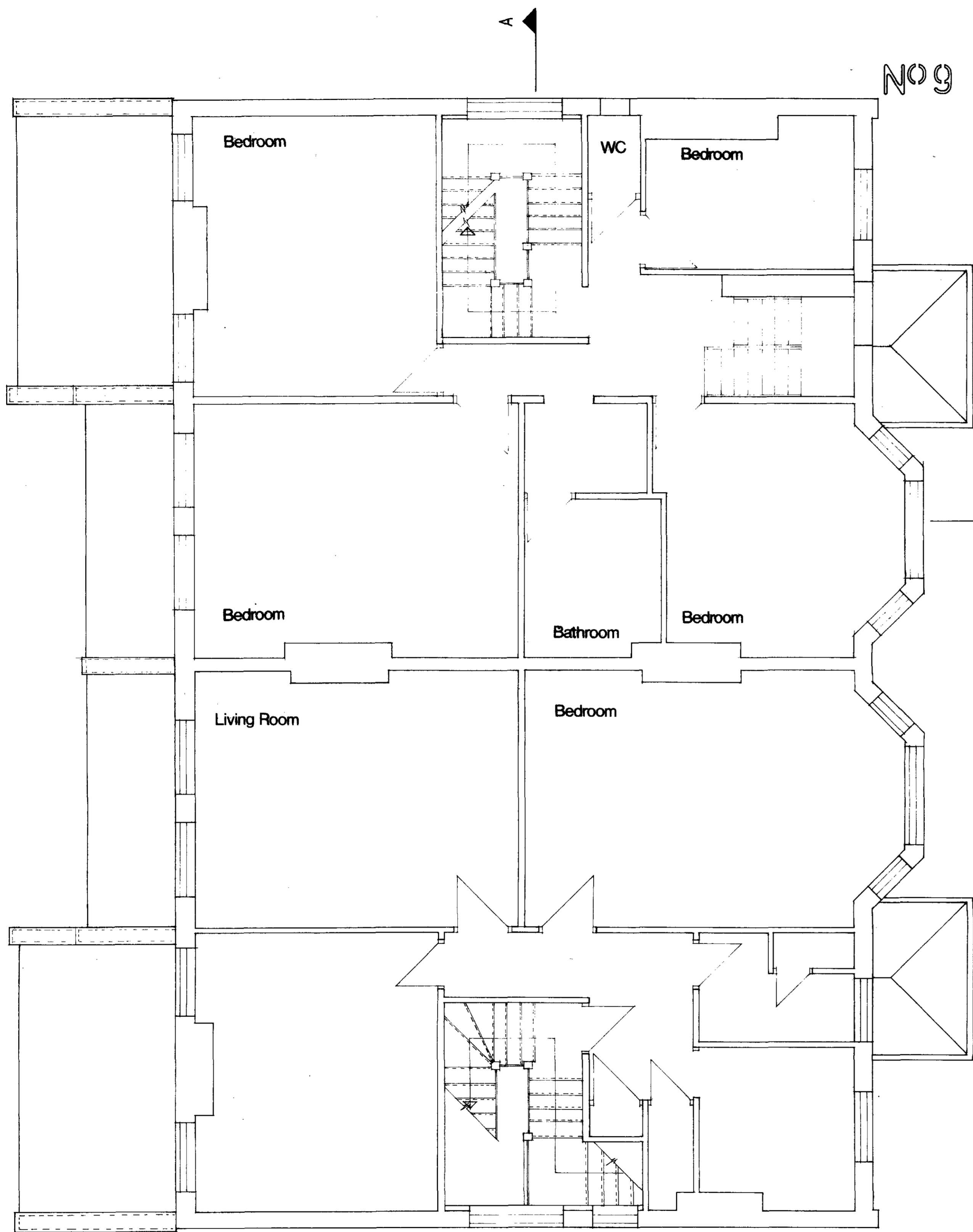

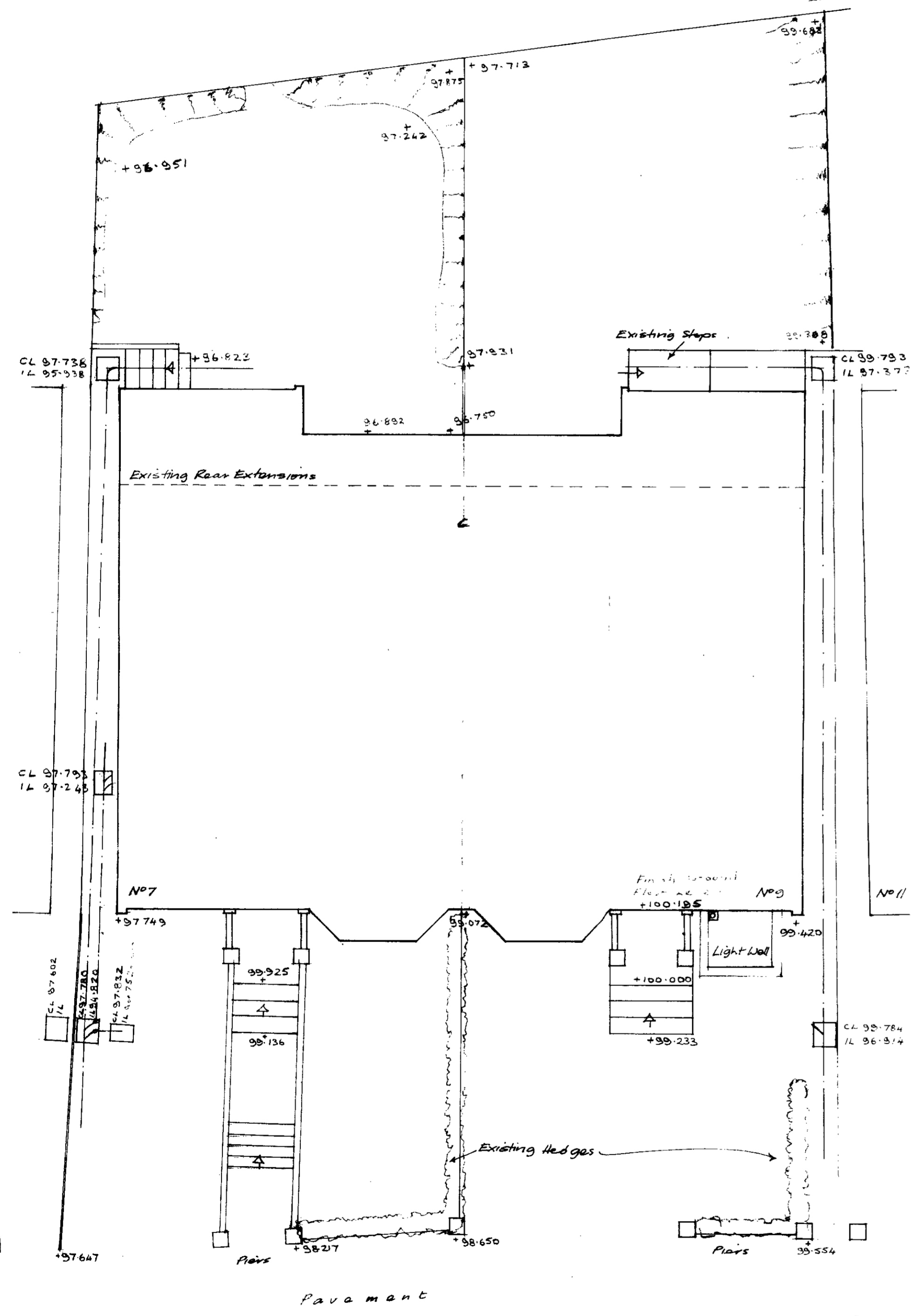
