The only problem I have now is that the application is for advert consent and the side triangle shapes and the overhead sign constitute adverts but installing acrylic to the sides and roof of the metal structure to enclose it actually requires planning permission rather than advert consent. I'm happy to recommend approval for the signage (i.e. the acrylic triangles at the sides and the overhead sign – when I've got the scaled plans) but in order to enclose the structure with acrylic I'm afraid you will need to submit another application for planning permission. There will be no fee for the application because you are entitled to a 'free-go' within 12 months if the development relates to the same site.
