01 THE AGREEMENT

THE LISTED BUILDING HERITAGE PARTNERSHIP AGREEMENT (the Deed) is made on the XXXX day of XXXX 2016 BETWEEN

- (1) **LONDON BOROUGH OF CAMDEN** Regeneration and Planning Development Management, Town Hall, Judd Street, London WC1H 8ND (hereinafter called "the Council") of the first part
- (2) **LONDON BOROUGH OF CAMDEN** Housing and Adult Social Care, 33-35 Jamestown Road, London. NW1 7DB (hereinafter called the "Applicant")
- (3) THE HISTORIC BUILDINGS AND MONUMENTS COMMISSION FOR ENGLAND of 1 Waterhouse Square, 138-142 Holborn, London EC1N 2ST

RECITALS

- 1.1 The Council is the Relevant Local Planning Authority for the purposed of the 1990 Act in respect of the Land
- 1.2 The Applicant is the registered proprietor of the freehold interest in the Land registered at HM Land Registry under the title number ?????
- 1.3 HBCME is the statutory advisor to the Government in relation to the historic environment.
- 1.4 The Alexandra Road Estate (hereinafter called the "Estate") was listed at Grade II* in 1993 See Map with Listing Description at Section 1C-06 and Location Plan Drawing No: 2504/L/001 in Section 1C.
- 1.5 The Council has agreed to enter into this LBHPA and to grant Listed Buildings Consent for the Consented Works to the Listed Estate having reference to the applicable polices that would be considered as part of a Listed Building Consent application and having regard to the provisions of the Council's Policies, Development Plan Documents and all other material planning considerations and considers that the proposals strike an appropriate balance between preserving and enhancing the Listed Estate's special architectural and historic interest and allowing the Estate to cater to modern demands of family living..
- 1.6 The parties to this Deed have agreed that Listed Building Consent should be granted in respect of the Consented Works to the Estate.
- 1.7 In accordance with the Regulations the Council has consulted HBCME and has taken into account the representations made in respect of this LBHPA.
- 1.8 The Council has informally consulted with the 20th Century Society
- 1.9 In accordance with the Regulations the Council has made the details of this LBHPA, the Consented Works and the Statement of Reasons (found in Sections 2B & 2D) available for inspection by the public.



2 **DEFINITIONS**

- 2.1 "the 1990 Act" means the Planning (Listed Buildings and Conservation Areas) Act 1990 as amended
- 2.2 "the Applicant" means London Borough of Camden
- 2.3 "the consented works" means those works described in Clause 7
- 2.4 "High Significance Kitchen" means a kitchen that exceeds the threshold on Schedule 1 of the Assessment Flow Chart (included at Section <u>2B-01</u>) for the particular dwelling type.
- 2.5 "Historic England" means the HBCME
- 2.6 "the Land" means that land on which the Estate is located and which is adjacent to the Estate and within the Applicant's ownership and control
- 2.7 "LBHPA" means a Listed Building Heritage Partnership Agreement made pursuant to Section 26A and 26B of the 1990 Act
- 2.8 "Listed Building" means a listed building as defined in Section 1(5) of the 1990 Act
- 2.9 "Listed Building Consent" means a consent for works as defined in Section 8(7) of the 1990 Act
- 2.10 "Low Significance Kitchen" means a kitchen that does not reach the threshold on Schedule 1 of the Assessment Flow Chart (included at Section 2B-01) for the particular dwelling type.
- 2.11 "The Partners" means the Council and HBMCE
- 2.12 "the Regulations" means the Planning (Listed Buildings and Conservation Areas) (Heritage Partnership Agreements) (England) Regulations 2014
- 2.13 "the Relevant Local Planning Authority" means in relation to a listed building, means a local planning authority in whose area the building or any part of the building is situated
- 2.14 "the Statement of Reasons" means the statement of reasons produced by the Local Planning Authority in accordance with the Regulations





3 LEGAL EFFECT

- 3.1 This Deed is made Pursuant to Section 26A of the 1990 Act, the Regulations, Section 11 of the Local Government Act 1972, Section 2 of the Local Government Act 2000 and all other enabling powers and grants Listed Building Consent in respect of the Consented Works to the Listed Estate subject to the conditions set out in the Consented Works section of this Deed.
- 3.2 The provisions of this Deed are enforceable by the Council as Relevant Local Planning Authority

4 MISCELLANEOUS

- 4.1 The parties to this Deed acknowledge and agree that the following works fall outside the controls of the LBHPA:
- 4.1.1 Works which can be categorised as de minimis and which are not the subject of this LBHPA. Listed Building Consent is needed for any works of demolition of a listed building or for its alteration or extension in any manner which would affect its character as a building of special architectural or historic interest. Any works which do not affect the character of the listed building in such a way do not need Listed Building Consent.
- 4.1.2 Works which are not Consented Works under this Deed and which affect the character of the Listed Estate as a building of special architectural or historic interest require Listed Building Consent.





5 THE HERITAGE ASSET

- 5.1 This LBHPA relates to The Alexandra Road Estate. The Estate comprises a number of linked buildings and areas, which are shown on plans in Annex *, as follows:
 - Blocks A1 to A5
 - Blocks B1 to B3
 - Blocks C1 to C3
 - Tenants Hall / Boiler House
 - Resource (Youth) Centre
 - Estate Management Offices
 - Landscaped Park / Play Areas
 - Rowley Way Shop

6 STATEMENT OF SIGNIFICANCE

6.1 Designed in 1968 and built between 1972 and 1978 by the London Borough of Camden Architects Department, Alexandra Road Estate is one of the most ambitious examples of the innovative new social housing emerging from the Department at this time, and of new housing in Britain. Its architect was Neave Brown.

Camden was formed in 1965 from the London Boroughs of Hampstead, Holborn and St Pancras and was one of the largest, wealthiest and most ambitious of the new London Boroughs. The architect's department under the leadership of Sidney Cook was, like all local authorities, under great pressure to build large amounts of housing. Camden developed low rise, high density schemes to meet this demand rather than the system built high rise schemes adopted by many other local authorities. The Estate was seen as an opportunity to improve a whole area by the inclusion of a public park and the provision of social buildings such as the community centre, shops and special needs school.

The street is the dominant element in the design and seen as a modern translation of the traditional London Street, where the sum of the whole exceeds the individual parts in creating a meaningful urban space. All dwellings are entered directly from the streets, which are freed of traffic by the parking garage provided at low level. At Alexandra Road, Rowley Way can be seen as one of the most successful examples of the segregation of traffic and the pedestrian, and it remains a successful social space.





The linear stepped section was influenced by work developed by Leslie Martin - an idea also developed by Denys Lasdun at the University of East Anglia (1962-68) and by Patrick Hodgkinson at the Brunswick Centre in Bloomsbury (1967-72). At Alexandra Road the stepped section enabled all dwellings to have a sunny outdoor space and was further utilised to shield the estate from the noise of the railway line to the north. Alexandra Road Estate also represents a development of Neave Brown's earlier work for housing societies, undertaken while he was in private practice, at Winscombe Street and Fleet Road. Though on a much smaller scale, these too were essays in high-density developments of stacked dwellings and the considered sequencing of spaces moving from public and semi-public to private and semi-private.

The construction of the Estate is of white board marked concrete with areas of self-coloured render. The predominant materials are light in colour with contrasting joinery, inside and out. Concrete was the natural material from which to form the large, complex section, and the areas of self-coloured render reference the Regency terraces. At Alexandra Road the quality and detailing of the materials is high. Internally the planning of the individual flats has been carefully thought out to maximise the use of limited space, flexibility is introduced by dividing spaces using storey height doors and sliding partitions. The care devoted to the internal fittings was perhaps unique amongst local authority departments at this time – all internal joinery – cupboards, wardrobes, shelving and staircases is bespoke and was carefully detailed by the architects to carry through the concept of the design.

The quality and importance of the estate has been widely recognised both in England and abroad. It is a powerful icon of the optimism and idealism that underpinned post-war public sector architecture. It continues to be regularly visited by architectural students and practitioners.

7 DESCRIPTION OF THE CONSENTED WORKS

7.1 Summary Description of Consented Works:

This Listed Building Heritage Partnership Agreement is a pre-cursor to a wider Agreement which will cover all aspects of the Listed Estate within the ownership of London Borough of Camden. The Consented Works in this Agreement are limited to those works necessary to deliver a 'Better Homes Programme' of works namely improvements to the kitchens and bathrooms plus re-wiring within the dwellings.

The London Borough of Camden is delivering a 'Decent Homes Programme' of works across the whole of its housing stock This programme, introduced by the Blair-Brown Labour Government aims to provide a minimum standard of housing conditions for all those who are housed in the public sector – i.e. council housing and housing associations. The consented works get as close as possible to the Decent Homes Standard whilst taking account of the significance of this Grade II* Listed Estate.





Full Descriptions of the proposed works can be found on the drawings in Sections 2B and 2D and in the Specification but are specifically as follows:

- 7.1.1 Works to kitchens identified as 'High Significance' (a kitchen that exceeds the threshold on Schedule 1 of the Assessment Flow Chart (included at Section 2B-01) for the particular dwelling type) include the repair and/or replacement of cabinets and tiling, and the partial removal of concrete worktops to be replaced with thinner solid timber worktops to allow the installation of washing machines and enclosed storage, the removal of cabinets over cookers, and the installation of new floor finishes.
- 7.1.2 Works to kitchens identified as 'Low Significance' (a kitchen that does not meet the threshold on Schedule 1 of the Assessment Flow Chart (included at Section 2B-01) for the particular dwelling type.) involve the fitting of new cupboards, worktops, sinks and wall tiling and the installation of new floor finishes using materials sympathetic to the original design intent.
- 7.1.3 Installation of new sanitary fittings and tiles in bathrooms.
- 7.1.4 Replacement of wiring, including surface mounted trunking where necessary plus doubling and/or additional sockets where possible.

7.2 Details of Location of Consented Works:

The works will take place in London Borough of Camden Tenanted properties on the Alexandra Road Estate. Leasehold properties are excluded. A full list of addresses is given in Section 1C-02 Use of the Estate and below.

7.3 Justification for The Works:

The kitchens are 40 years old and require work to bring them back to a serviceable condition and adaptations to meet modern needs and standards. At the time the original kitchens were designed and constructed provision was only made for a cooker and fridge and we know from the architect Neave Brown that the Council at that time provided a Communal Laundry on the Estate rather than make provision for washing machines in each dwelling. That Laundry is no longer in operation and there is an expectation in a modern home that there will be space for an automatic washing machine to be plumbed in.

The works, therefore, include the either the refurbishment or replacement of kitchen fittings dependant on whether the kitchen is identified as High or Low Significance but in either case adaptations to accommodate modern appliances of cooker, fridge freezer and washing machine. Provision will also be made to comply with current Gas Regulations which will require the removal of some cupboards from above cookers, where they currently exist.

The Council recently undertook a condition survey of the properties which included the statutory periodic inspection of the electrical wiring. As a consequence a significant number of properties will also need to have their wiring replaced as part of the works to be carried out under this Agreement.

- **7.4** Associated Conditions (to be completed Historic England following Public Consultation)
- 7.4.1 The works shall be completed within 9 years from the date of this Listed Building Heritage Partnership Agreement.





- 7.4.2 Records are to be provided of the property before works are carried out and after completion.
- 7.4.3 Work to be carried out as described on drawings in Sections 2B and 2D
- 7.4.4 Materials shall be as stated on the consented Drawings and in the consented Specification
- **7.5** Reasons for Conditions: (to be completed by Historic England following Public Consultation)
- 7.5.1 Works must be completed before the expiry of this agreement.
- 7.5.2 Records confirm that the Assessment Procedure has been carried out correctly and to avoid the unnecessary loss of historic fittings and/or materials.
- 7.5.3 To protect the Heritage Asset.
- 7.5.4 To ensure that the materials used match or are sympathetic to the original design and design intentions.





8. STATEMENT OF REASONS FOR THE CONSENTED WORKS

9. OTHER AGREEMENT PARTICULARS

- 9.1 This Deed will run for a period of ten years (subject to Clauses 9.11. and 9.12 below), with a review period at year five and year nine (such reviews to take place in accordance with Clauses 9.6 to 9.9 below).
- At year nine, any works expected to continue into year ten may require a standalone application for LBC unless the LBHPA is renewed before the expiration of the Agreement, under full consultation and in accordance with Clauses 9.11 and 9.12 below.
- 9.3 Any other works which go beyond those identified in this Deed and Annexes may require Listed Building Consent in accordance with current legislation, including any demolition or new build. Further detail on when Listed Building Consent will be required is included in Annex *.
- 9.4 Nothing in this LBHPA restricts or is intended to restrict the proper exercise at any time by the Council of any statutory power, function or discretion in relation to the Station.
- 9.5 The LBHPA will be registered as a local land charge by the Council.

Review, Variation and Termination

- 9.6 The LBHPA will be reviewed by the parties in the fifth and ninth years of the date of the LBHPA being entered into.
- 9.7 The Council shall co-ordinate a meeting (the 'Review Meeting') for the Partners in order to discuss the provisions of this Deed and how the provisions are or have been implemented.
- 9.8 Should any issues arise from the Review Meeting, the parties shall engage in constructive dialogue to resolve any issues. Should this necessitate modifications to the LBHPA, then the relevant requirements as set out in legislation will be followed. The Council and the HBMCE shall not unreasonably withhold or delay agreement to any modifications to this LBHPA requested by the Applicant.
- 9.9 In addition to the Review Meeting at the mid-point of the term of the LBHPA, the Council shall co-ordinate regular (bi-annual) meetings (The Listed Building Group meetings) between the Partners, as an informal opportunity to review the running of the LBHPA and address any issues arising, and as an opportunity for the Applicant to appraise with Partners of any emergency works, or Future Projects anticipated, or the addition, removal or modification of the LBHPA. The Council and the HBMCE shall not unreasonably withhold or delay agreement to any modifications to this LBHPA requested by the Applicant.





- 9.10 This Deed will terminate on the tenth anniversary of the date of the Deed unless the terms of the LBHPA are renewed in accordance with Clauses 9.11 and 9.12 below.
- 9.11 The LBHPA is renewable for subsequent [10 year terms] upon the written agreement of all parties to this Deed. A request for renewal shall be made of the Council and the HBCME in writing [3] months prior to the termination of the relevant term of the LBHPA. Any renewal request shall set out the reasons and justification for the request and shall be considered in accordance with the Regulations.
- 9.12 The Council and the HBCME shall not unreasonably withhold or delay agreement to a renewal request. At the time of any such renewal the parties shall determine and agree in writing any modifications to this LBHPA including but not limited to the definition of Consented Works. The Council and the HBMCE shall not unreasonably withhold or delay agreement to a renewal request and/any modifications to this LBHPA requested by the Applicant.

Records

- 9.13 The Council will keep a record of all notes and works under the Deed, including a record of Listed Building Group meetings in the form of archived minutes and at least one copy in hard copy. Each year this record will be submitted electronically by 31st March for the Partners for review.
- 9.14 Recording by drawing or photography in advance of works secured by condition may be appropriate in certain circumstances, particularly where a degree of harm is outweighed by the benefits of the works. Such conditions should be tailored to the circumstances in each case and any such records made should be deposited with the archived minutes.
- 9.15 The Council will by 31st March each year send written notification to the Council and HBMCE of all works that have been carried out under the LBHPAs or a Lawful Development Certificate as a written record of change to the heritage assets.

Revocation

9.16 The LBHPA can be revoked provided all parties agree to its revocation. Should one or more of the parties disagree with the proposal to revoke then the LBHPA will terminate in the tenth year unless, the parties determine it can continue with/without agreed modifications in accordance with Clauses 9.11 and 9.12 above.

It is understood that this is an important document for the continued management of the estate, and all relevant information gathered during the use of this document is to be integrated at the annual review of this document.

It is essential that all proposals affecting the estate are considered in the light of this Agreement. The undersigned parties agree to abide by the recommendations laid down in the document, and to work to introduce new standards where recommendations are unavailable.
