The extension may well mean a view through Burdett Mews' skylights and thus an invasion of privacy for these residents. As my house is at the back of 3 Belsize Crescent (share a wall), my skylight will be the nearest and easiest to look down in to. 2. In order to build this extension (or do any external work for that matter), will require stories of scaffolding on my flat roof. Again, this will mean an invasion of privacy through my skylight plus, more importantly, a very real risk of roof and property damage. The roof is constructed with joists and I am almost certain that the roof will not withstand the weight of the scaffolding and building materials. This may well cause significant damage to my property and I am not willing to take this risk. Finally, to have a temporary structure on my roof which will be in constant use most of the day (including Saturdays) will be a massive noise disruption for me – something I am unwilling to put up with. 3. As I share a wall with 3 Belsize Crescent, I am aware of the damp in this wall. My side was damp proofed some years ago, but as 3 Belsize Crescent is office space it is highly unlikely that the damp has been addressed properly, if at all, on their side. To add tonnes of weight to a wall that is already very wet and visibly compressing (cracks), is damaging to my property and irresponsible. <p>I object to building a second floor rear window for the following reason:</p> <ol style="list-style-type: none"> 1. The windows may well mean a view through Burdett Mews' skylights and thus an invasion of privacy for these residents. As my house is at the back of 3 Belsize Crescent (share a wall), my skylight will be the nearest and easiest to look down in to.
