Informally, the gate does not appear to harm the conservation area on account of its similarity to what is presently existing and thus preserves the conservation area. I am not sure whether the gate is within the curtilage of the listed building however it would impact the listed buildings setting and thus would likely require listed building consent.
If the applicant wished to proceed with the gate and waste storage I would recommend a planning application or householder if the site is a dwelling house and a listed building consent application.
