Apple: Fell to ground level - The tree is leggy with sparse lower canopy, poor form, shading gardens, effecting neighbours. Close to boundary wall.

Goat willow: Fell to ground level - pushing over wall becoming too large, poor form, close to properties and casting a lot of shade over the gardens and properties
