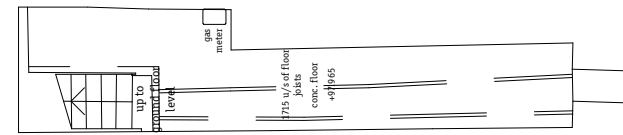
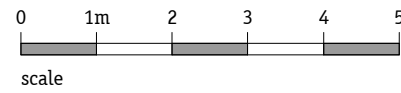




existing first floor plan

existing basement floor plan



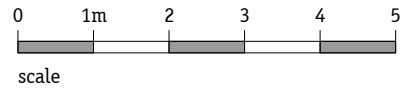

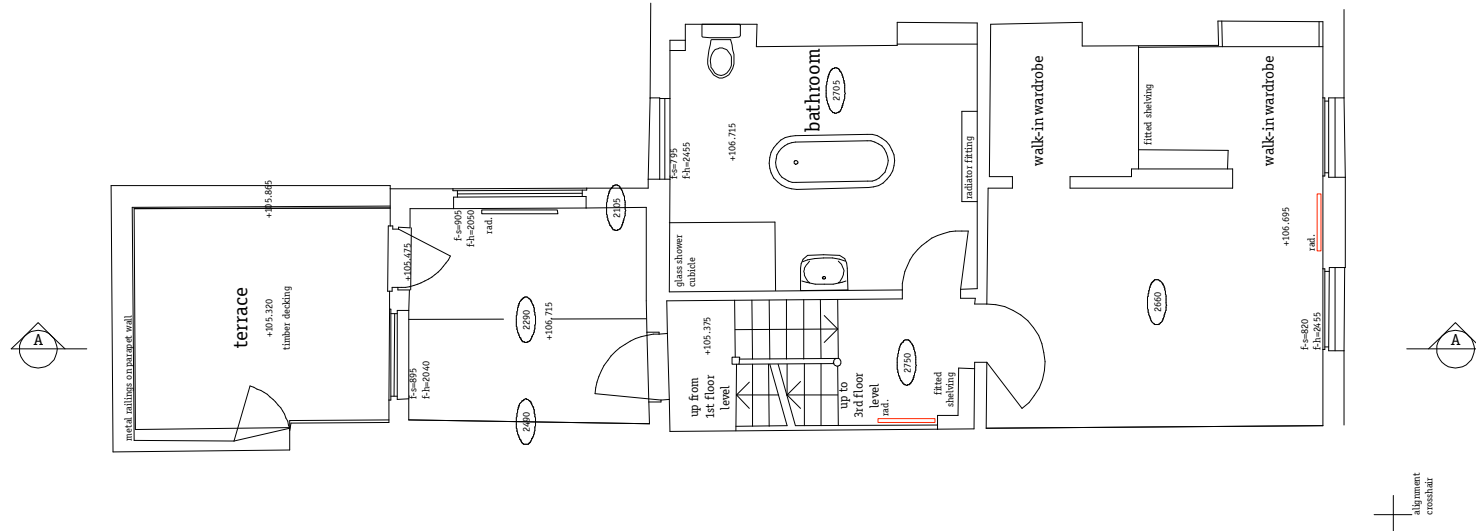

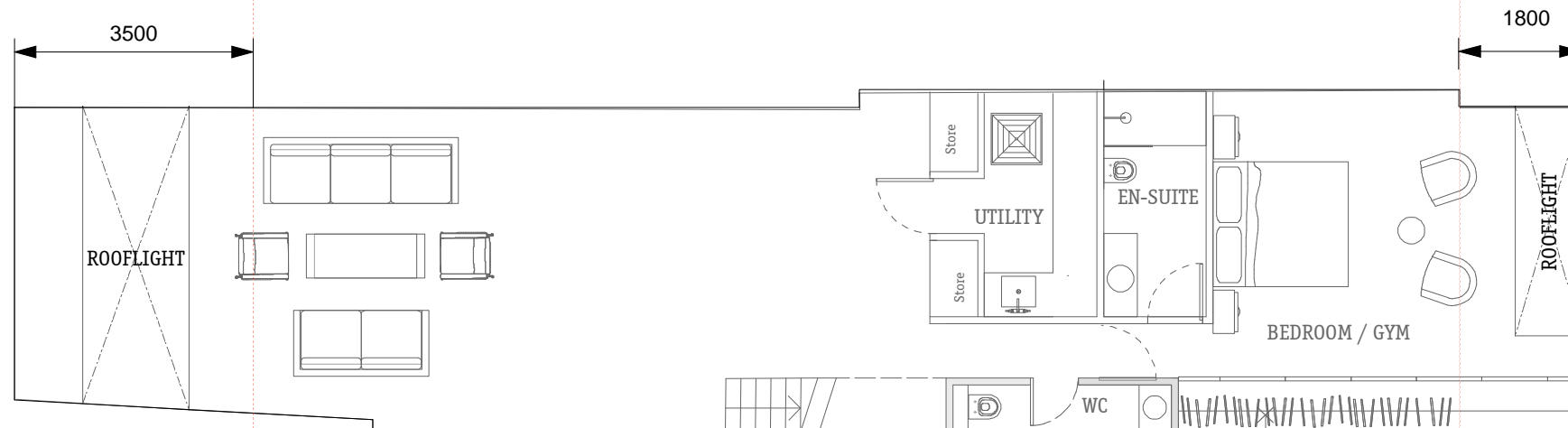

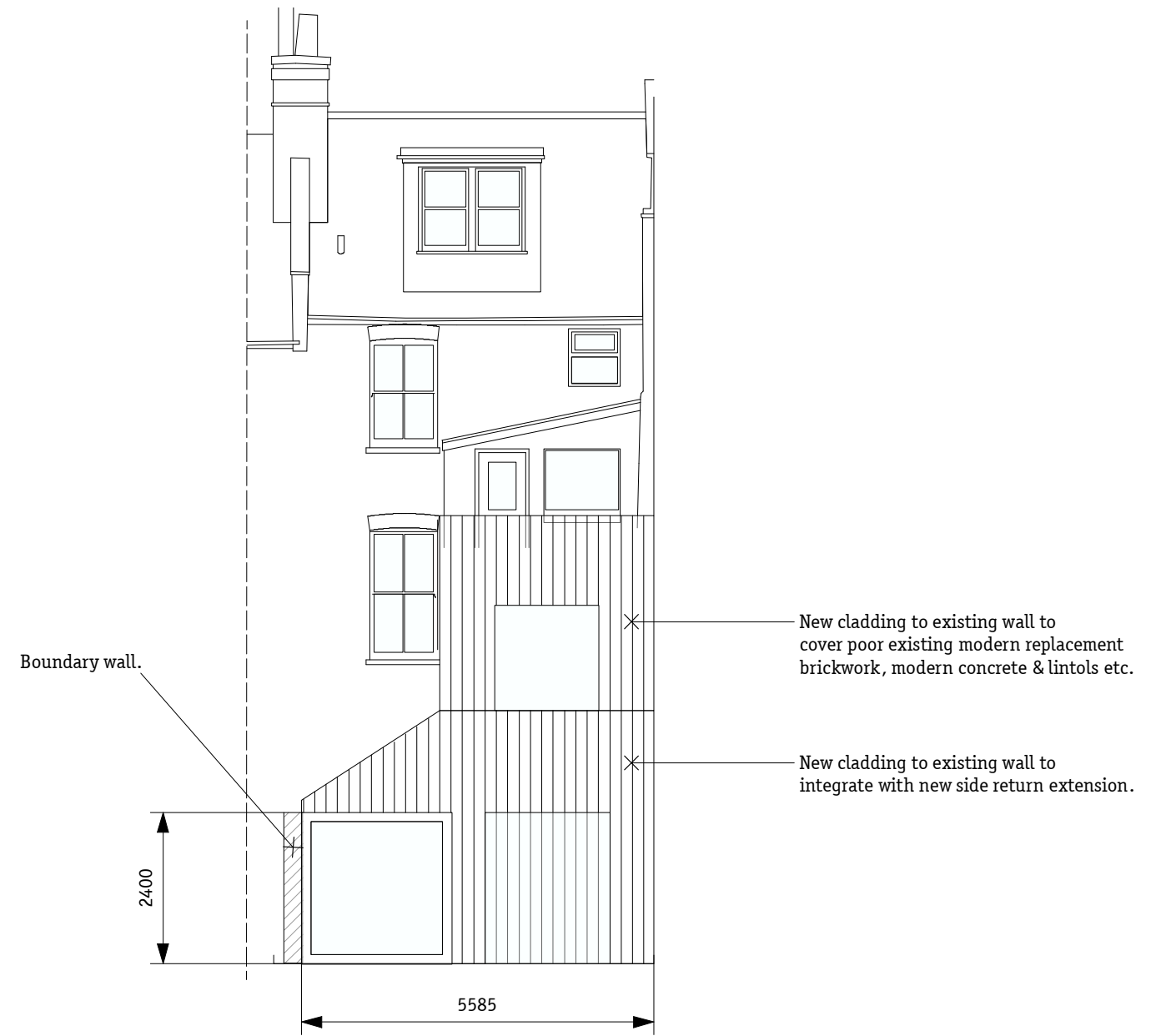
