These multi-storey towers are totally out of keeping with the residential area of Somers Town. They will tower over existing buildings and streets and make the area feel imposing and closed in. In particular, the building of such a tall tower on the open space will totally alter the character of this park and make local people like myself much less likely to use it. There is no precedent for building residential buildings of this height within Somers Town - no other building will come anywhere near the height except the Crick which is on the very edge of the area. The imposing height of this building already has a negative impact on the Somers Town area in my opinion. Please let us not have any more buildings of this height - it will spoil the area!</p>

My maisonette is already quite dark so further loss of daylight is problematic. It will affect my electricity bills and make an unpleasant working environment.</p> <p>Noise during construction - working from home involves voice recording so the construction period will directly affect my livelihood.</p> <p>Loss of mature trees combined with a 25 storey building, and 2 others on the park will change the character of the area and make the air quality even worse. Given the proximity of the Crick and the proposed tower the scheme is overpowering and claustrophobic.</p> <p>The influx of people this development could bring will overstretch local services and facilities. E.g. Local GPs are already over subscribed, and green space isn't sufficient for so many people.</p> <p>Reduced parking - increased pressure on what parking there is in Somers Town.</p> <p>The Brill Place tower is not in the CAZ, its on a neighbourhood park, so should not be subject to those planning allowances on building heights.</p>

Already space allocated to social housing and meeting local need has been taken up by the Crick development.</li> <li>2. Gentrification - high cost housing will increase social polarisation. Camden policy CS6.</li> <li>3. Loss of green space / amenity. Parks are being lost and replaced by hard landscaping. People will use the new space differently . The existing parks are the only green social space in Somers Town. The new spaces are mainly paved for people to pass through the area.</li> <li>4. The tall building on Brill Place will block light, creating a cold and windy walkway.</li> <li>5. More buildings taller than existing ones will change the skyline and block light.</li> <li>5. Loss of so many trees -we are in an urban hub - there is a lack green space and trees anyway. The loss of mature trees will contribute already poor air quality and health problems, especially including mental health.</li> <li>6. Impact on mental health - people need green spaces like parks for social inclusion, relaxation and better quality of well-being. It will be very claustrophobic and we are concerned about health. The air quality is already poor.</p> <p>In the past big construction sites creating noise and dust in the area have affected our sleep and health. This is another big development which will do the same.</p> <p>We can see the park from our balcony but what view we have left will be taken by the tower block.
