King's Cross Central: Reserved Matters Submission for Camley Bridge (and accompanying Conservation Area Consent Approval of Details Application and Notification of Proposed Works to Trees in a Conservation Area)

Please find enclosed an application for approval of details relating to Camley Bridge, as listed above, and notification of proposed works to trees in a Conservation Area.

The submission site is located in the northern western quarter of the King's Cross Central ('KXC') development and takes in airspace over the Regent's Canal and land within the Camley Street National Park, ('CSNP') all within the Outline Planning Permission boundary.

The Reserved Matters submission addresses the relevant conditions set out in the Outline Planning Permission granted on 22 December 2006, with reference 2004/2307/P.

The application is made by Argent (King's Cross) Limited on behalf of King's Cross Central General Partner Limited ('KCCGPL').

The proposed Camley Bridge is composed of a bridge deck, two abutments and a ramp, which curves around the northern edge of the Camley Street Natural Park ('CSNP'), and associated landscaping. Camley Bridge will measure 3.5 metres in width, across its full 93 metre length, of which 38 metres will form the bridge deck.

The proposed bridge will provide a strategic cycle and pedestrian route across the Regent's Canal and the Camley Street Natural Park, open between the hours of 6am and 9pm, daily, year-round.

The bridge is designed by Moxon Architects, with input from the London Wildlife Trust ('LWT') on the planting element of the proposals within the CSNP. The eastern landing, where the bridge interfaces with KXC, has been designed with Townshend Landscape Architects (TLA), who were responsible for the earlier approved designs for the Gas Holder Gardens and the Wharf Road Viaduct. Both designers have worked closely together to ensure a cohesive design with the proposed bridge's surroundings.

The proposals are set out in more detail in the enclosed submission documents, which comprise the following:
