This letter invites your views regarding 3 applications submitted for the approval of details and their subsequent appeals as follows:

1. APPROVAL OF DETAILS CONSULTATION &

2. NOTIFICATION OF AN APPEAL AGAINST NON DETERMINATION OF THE APPLICATIONS

We have received 3 applications for approval of alternative details, reserved by condition, following the grant of planning permission as specified above. The applications have been held in abeyance by the Council. Appeals however have now been submitted against the Council's non determination. This means that the Planning Inspectorate will determine the applications following submission of the Council's statement setting out what the Council's decision would have been had the appeals not been lodged.

Firstly therefore we are inviting you to comment on the applications so that your views can be taken into account before the Council forms its views on the merits of the applications and submits the appeal statements to the Planning Inspectorate.



Your views will be copied and forwarded to the Planning Inspectorate and the people who have made the appeal. These comments will be taken into account by the Inspector, along with the Council's statement, in deciding the appeal.

Secondly, in addition this letter formally notifies you of the appeal as required by the Planning Inspectorate.

The Council welcomes comments from tenants and owners. If you are not the owner of the property you occupy, can you please also tell the owner about this letter.

Details of the Planning Appeal

The appeal is to be decided by an Inspector from the Planning Inspectorate on the basis of an exchange of written statements between the people who have made the appeal and the Council, followed by a site visit.

In addition to the Councils formal consultation period, the Planning Inspectorate's formal consultation period runs until 23rd February.
