The Council has considered your application and decided to grant permission.

Informative(s):

1 Reason for granting:

The lighting details satisfactorily demonstrate that the external lighting luminance and design of fixtures will protect visual amenity, the setting of the gasholder and will secure a safe and secure environment. The luminance is of an appropriate level to ensure it will not impact on the amenity of nearby residential properties.

The paving and hard landscaping proposal comprises sandstone paving, reclaimed, sawn and new granite setts in appropriate locations, granite paving, sandstone tactile paving, granite steps and kerbs around the gas holder and planters. The materials are considered to compliment the historic gas holder and the materials used surrounding the gas holder are consistent with the approach and materials used on the wider site. The planters, benches and seats on Canal Reach would be granite and timber and within the gas holder would be stone. The materials would complement the public realm. The balustrades would be of a simple design which will ensure safe access without detracting from the appearance of gas holder. As such, all details are considered acceptable and will ensure a high quality finish to the building and the surrounding public realm.

As such, the details are in general accordance with policies CS5, CS14 and CS15 of the London Borough of Camden Local Development Framework Core Strategy, and policies DP24, DP25 and DP26 of the London Borough of Camden Local Development Framework Development Policies.

2 You are advised that all conditions relating to reserved matters approved granted on 28/08/2014 reference 2014/3681/P which need details to be submitted, have been approved.

In dealing with the application, the Council has sought to work with the applicant in a positive and proactive way in accordance with paragraphs 186 and 187 of the National Planning Policy Framework.
