Front Garden T1 Beech- Reduce heigh by approximately 2m beyond previous pruning positions. Reduce all side growths by a lesser extent to reshape, and leave a natural outline. Leave as many buds and twiggy growth as possible to facilitate a healthy recovery. T2 Horse Chestnut- Same as T1.

Reasons for both T1 and T2- Routine maintenance, and loss of light to front of property.
