Rear Garden:  
TPO Lime: Approximately 12.00-13.00m. Fell to ground level and replace with two birches. Reasons: Fruiting body is present close to ground level therefore it is reasonable to presume that basal decay is present. Past pollarding has caused some longitudinal decay pockets in the upper crown. The tree is in close proximity to the boundary wall. Intensive management in past years has reduced its aesthetic value. It is therefore likely that the tree will need to be removed in the medium term. By replacing the lime with two birch trees along the boundary the tree stock in the conservation area can be preserved.
