2015/5412/P	126 The Studio Greencroft Gardens NW6 3PJ	Replacement of the existing fibre cement roofing with zinc roofing and the incorporation of two fixed roof lights to the existing studio building to the rear of No.126 Greencroft Gardens.
2015/5536/P	13 Elsworthy Road, NW3 3DS	Construction of single storey garden room, ancillary to the existing dwellinghouse and associated landscaping works.

Thereafter apply a liquid waterproofing system before reinstating all steps and finishes to existing levels with matching materials. Localised brickwork repairs to the surrounding structure. Localised repointing of slabs at ground floor level.
2015/5477/P	Flat 1,172 Goldhurst Terrace, NW6 3HN	Replace existing windows at ground floor front elevation with double glazed timber framed windows to match existing and add one enlarged timber framed replacement window.
