The site will be used to display luxury supercars available to rent. All vehicles will be high value and will be entering the property through the current entrance from the rear of the property. No highway changes are required as there is vehicular access from the rear and shutters are installed. The previous shop had already installed shutters to allow vehicles access. No vehicle will be entering or exiting from the front of the shop. Vehicles will be on display in a clean condition any bookings would be taken via staff on site or website. A strict insurance policy would be in place for clients to meet certain criteria in order to be eligible for renting the vehicle.

In a 30 day period we expect 20-25 rentals to take place.

This would be extremely low numbers of people coming to the shop in comparison to carphone warehouse having this number in one day of trading. So we are proposing a use which will have very little impact on locals in regards to traffic and public entering the premises.
