This tree has limited future prospects due to its close proximity to the building. Further more it is of low amenity value because whilst heavily overshadowing the area, at the same time it prevents a view of the mature tree specimens in the park immediately opposite. In other words without this tree in place the amenity value of the specimen trees in the area will improve and the street / house area will be lighter and more appealing.

The main reason for the proposed work is that the tree is having a real and quantifiable affect on the health of the residents. Please see the attached document "Resident Statements 10RT". In considering this request it is incumbent upon the Borough to consider the wellbeing and health of the residents situated here. It would be appropriate to contact the residents to thoroughly examine the situation - details are in the statement document
