I object to the major redevelopment of the residence adjoining Air Studios in NW3, Rosslyn Hill.

I particularly object to the fact that the applicants are trying to circumvent the planning process by putting in another application that is practically identical to the first one in the hope that Camden would nullify all the previous objections. And indeed, I understand that Camden has interpreted the effect of the planning rules to mean that all of the old objections to the first application cannot be transferred to the second one. This is absolutely preposterous, and a total waste of time for everyone concerned. Camden cannot possibly think that the huge number of objectors to that first application are going to change their minds. It just means we all have to go through this process a second time, at a considerable cost to Camden of time and money. It really boggles the mind.

We do not want the development of two basements next to an historic building that is going to suffer not only from the noise, but by almost certain structural damage.

As a longtime Camden resident, and one who has suffered through the development of two basements in the immediate vicinity of my home, I know how painful and debilitating this whole process can be for the neighbours, and we are not even trying to run a music business that depends on peace and quiet.




Please recognise the devastating impact of that when considering these new applications.

I am writing to object to the planning application listed above.

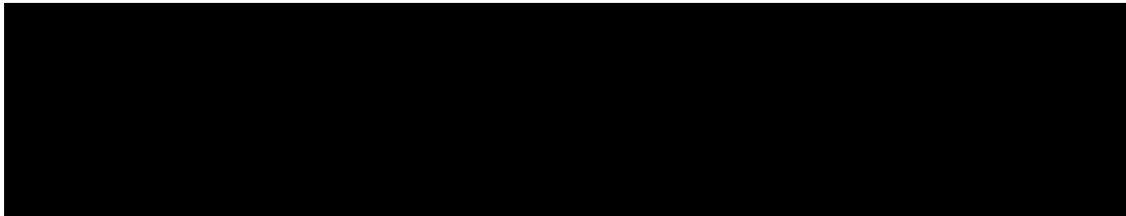
I am also disappointed that my original objection can not be applied to the second application.

Please re think your actions.



Further to the email I sent a few minutes ago, I would like to add the following points which are of the utmost importance when considering this application:

The problem with this development is that it may close the business of Air Studios for the following reasons:

1. As a recording studio it is extremely noise sensitive and if work of this nature and length were to be granted the go ahead it would render the studios inoperable for a long period of time.
2. This would not only result in loss of earnings for the company but would affect many musicians and orchestras, film companies etc as there are not enough alternate facilities available in London or the UK.
3. The structural risk is serious. The basement, whose construction would devastate the site, is far too big, and would not be acceptable under the Draft Local Plan now out for consultation. There are precedents for Draft Plans to be used in determining applications, especially in relation to listed buildings.
4. The Basement Impact Assessment states that damage to adjoining buildings would be no more than Burland Scale 2. This is too much, with unequal listed buildings on each side; one dating from the 18th Century, no doubt of rustic character, the other of late 19th Century, carrying a huge load. 

I am writing to object to planning applications reference

I believe that there has been a second application for planning to make basements below a house next to Air Studios, Belsize Park. As a professional singer working here on a regular basis, the loss of Air Studios would be catastrophic to the recording industry in the UK and would have enormous knock on effects for the professional singing business. Recording companies will take their work elsewhere (given that Air Studios would be undoubtedly out of action due to the noise), and it is unlikely we would ever recover that work. Not to mention the loss of income for hundreds of singers, recording engineers and other musicians whilst the work is taking place. Air Studios would not be able to survive with a considerable amount of time off any recording contracts whilst the work is taking place. I can't possibly see how the council could allow these two home owners to benefit to the detriment of hundreds of livelihoods..

I objected to the first planning application and I believe it is unreasonable to treat my original objection as not applying to the second application; the first application should be rejected and my original objection should stand for the first and second applications, as should everyone else's who wrote in for the first objection. This cannot be allowed to go ahead because of a loophole.

Dear Mr. Tulloch,

I am a composer based in Los Angeles, but I travel to London now and then specifically to record my work at the amazing AIR Studios. It's certainly more expensive than staying home and recording locally, but there's a reason that I -- and so many other LA-based composers -- make that journey and that investment. Because it's worth every penny.

AIR was always the stuff of legend: you'd hear stories about film scores recorded there and how the space was so perfect that it was magical. "Instruments came to life" is what people would say. "It sounds like I'm going overboard, but once you're there and you hear it, you'll understand." And in May of 2014, when I was at AIR Studios to record my album "The Architect" I learned that all of this talk wasn't hyperbole, and that when people say that this is the finest recording space in the world, they're not kidding.

I registered earlier objections to the proposed development underneath and around AIR Studios for the simple fact that this place is a treasure and should not be disturbed or put at risk. I was disappointed to learn that those old objections must now be re-registered under new application numbers. That seems a bit excessive, and like someone is trying to get around the system using some strange rules of order.

What I would encourage you to do, because I imagine you're getting a lot of notices like this, is to seek out an invitation to spend an hour at AIR listening to a recording session in the Lyndhurst Hall. You'll quickly understand why so many people are coming to the defense of this amazing place. The idea that it could be damaged in any way is simply devastating.

I urge you to reject the planning applications. Please don't put AIR Studios at risk.
