- T10 - T13 = 4 x XXL Planes - Clean through crowns removing deadwood, diseased and dying branches. Carry out a thorough inspection for Massaria infection and submit a written report.
- T14 - T21 = 8 x L Planes - Clean through crowns removing deadwood, diseased and dying branches. Carry out a thorough inspection for Massaria infection and submit a written report.
- T22 - T25 = 4 x XXL Planes - Clean through crowns removing deadwood, diseased and dying branches. Carry out a thorough inspection for Massaria infection and submit a written report.
- T26 - T30 = 5 x XL Planes - Clean through crowns removing deadwood, diseased and dying branches. Carry out a thorough inspection for Massaria infection and submit a written report.
- T31 = XL Planes - Reduce crown by 2-3 metres, prune to shape and tidy up.
- T32 - T34 = 3 x XL Planes - Clean through crowns removing deadwood, diseased and dying branches. Carry out a thorough inspection for Massaria infection and submit a written report.
- T35 = XL Plane - Recent work completed - No work required at this time.
- T36 - T39 = 4 x XXL Planes - Clean through crowns removing deadwood, diseased and dying branches. Carry out a thorough inspection for Massaria infection and submit a written report.
- T40 = XXL Plane - Tree hangs over the roadway - Clean through crowns removing deadwood, diseased and dying branches. Carry out a thorough inspection for Massaria infection and submit a written report. In addition, crown lift to 5.5 metres over roadway.
- T41 = XXL Plane - Tree hangs over the roadway - Clean through crowns removing deadwood, diseased and dying branches. Carry out a thorough inspection for Massaria infection and submit a written report. In addition, crown lift to 5.5 metres over roadway.
- T42 - T44 = 3 x XL Planes - All trees hanging over roadway. Clean through crowns removing deadwood, diseased and dying branches. Carry out a thorough inspection for Massaria infection and submit a written report. In addition, crown lift to 5 metres over roadway.
