Eucalyptus: Approximately 14.00m. Fell to ground level and replace with more suitable specimen tree.
Reasons: This is an inappropriate fast growing large species for its location. The tree is causing some visible damage to retaining walls and would require intensive management to keep at reasonable dimensions considering its proximity to buildings. There is already lifting of the pavement which may be attributed to this tree and it is most likely that if left, this tree will lift public footway in the future. The owner wishes to replace this tree with a heavy standard birch which would be more in keeping with native tree stock within the conservation area.
