I've written before, on this subject and have been forced to write again as it seems the Jeffrey's submitted another application without informing the studio (although they had previously said they were keeping all neighbours reliably informed).

As you already know the planned works have the potential to disastrously affect the future of the studio, and will have a knock on effect to the rest of the UK music business. If Air has to shut its doors for a long period then the Film Music Industry that has its heart based at Air and Abbey Road will be destroyed. Abbey Road will not be able to handle the overflow and the US based film companies will have no choice but to keep their work US based and Air will probably never recover from this.

Please consider this. Air Studios won the prestigious Studio Of The Year at the Music Producers Guild on Wednesday. It won the award for a reason.. it's simply one of the jewels in the crown of UK recording. It'll be disastrous if it's allowed to fade because of the disruptive nature of these planned works, should they go ahead.

This is regarding the application to build a private basement next to Air Studios, which would force Air Studios to shut down for months and months, due to construction noise. Not only would the closing of Air Studios endanger the livelihood of hundreds of professional musicians, recording engineers, composers, etc, it would also mean that London would no longer be seen as one of the best places in the world to record music, since that would leave only one working studio (Abbey Road). If both UK and international music recording projects are unable to use Air Studios' facilities for a long, indefinite period of time, then millions of pounds will be lost to London musicians and to the future of the recording industry here in London.

I am a professional violinist who has been privileged to record many film scores (including the soundtrack to the wildly popular "The Hunger Games" film) and video games at Air Studios. The recording industry gives me a large portion of my income, and I am pregnant with my first child, so understandably I am very worried about the loss of income that I personally would suffer if Air Studios is forced to close; not to mention the loss of income to the hundreds of musicians (who support families) that work consistently at Air Studios.

Please don't allow London's reputation, as a top city for the best music projects, to suffer, simply because one family wants to build an additional basement for their already substantial home. One family's unnecessary desires should not take precedence over the livelihood of hundreds of others.

Please do not approve this application for a major private development near Air Studios.

#### Dear Roh

I am writing to lodge my concerns about the above planning permission applications. I didn't write to you on the first application as I trusted the Council to take heed of the petition with over 11000 signatories, at present count. It seems that the Jefferies have found a way, by making a new but very similar application, to side step this considerable objection. The Application being so similar the issues in the petition still apply. Namely

- 1. As a recording studio it is extremely noise sensitive and if work of this nature and length were to be granted the go ahead it would render the studios inoperable for a long period of time.
- 2. This would not only result in loss of earnings for the company but would affect many musicians and orchestras, film companies etc as there are not enough alternate facilities available in London or the UK.
- 3. The structural risk is serious. The basement, whose construction would devastate the site, is far too big, and would not be acceptable under the Draft Local Plan now out for consultation. There are precedents for Draft Plans to be used in determining applications, especially in relation to listed buildings.
- 4. The Basement Impact Assessment states that damage to adjoining buildings would be no more than Burland Scale 2. This is too much, with unequal listed buildings on each side; one dating from the 18th Century, no doubt of rustic character, the other of late 19th Century, carrying a huge load. We cannot afford to see either damaged in any way.
- 5. Lack of compliance with proper process and also the risk attendant with the underground stream.
- 6. As yet there has been no consultation and no compliance with the Party Wall Act.

For me the primary issue is that the recording industry in London has been reduced considerably since Air studios was turned from an empty church into a vibrant recording location. When Air Lyndhurst was completed there were many commercial alternatives for recording large orchestras.

If several Feature films and TV Series were in the last stages of postproduction needing to record a score with live players there was capacity in the system. Not to mention the classical orchestras & commercial cross over artists who use large ensembles. At present there are only the 3 studios in red above remaining. It is now often the case that companies can not get recording spaces and end up going abroad. I happen to know that Abbey Road Studio 2 is closing for a refit in the spring this will put further pressure on the system. Any closure of Air Studios, even for a short time, will likely make London an unviable location for Hollywood composers like Hans Zimmer, Thomas Newman, Harry Gregson-Williams & John Powell, to mention just a few who have recorded here in the past 12 months. It costs very little to close a Studio but an enormous amount to start one.

Although I support the right for people to alter their property for their own enjoyment and trust the planning process to curb the enthusiasms of over zealous plans, I do not trust the Jefferies to play fair or see the greater cultural good in perspective. I therefore strongly urge you to take the stated wishes of over 11000 people into account that they wish Air Lyndhurst to continue to exist as a working recording studio.

I am writing to object to this planning application.

I am a professional musician who works frequently at Air Lyndhurst Studios. Air Lyndhurst, one of the finest recording studios in the world, is with Abbey Rd one of only two recording studios in London large enough to record major film scores.

Like many London-based musicians I depend on the film scores and other recordings made at the studio to support my family. Many of the musicians who work there are internationally acclaimed performers who rely on income from commercial recordings in order that they can pursue work that, while it may be more high profile, is often poorly paid.

As it is, occasional ambulance and police sirens can be heard from inside the studio meaning that that 'take' will be useless and that recording has to stop until the studio is quiet. If substantial excavations and building works are taking place immediately next to the studio, the studio will become unuseable for the duration of the works which, I believe, will be around six months. Even if agreements are offered to co-ordinate building work with recordings, it is inconceivable that film companies, often spending in the high tens of thousands of pounds a day, will be prepared to take the risk of losing very expensive recording time to site noise.

Air Lyndhurst will not be in any position to negotiate with those production companies. London is already one of the most expensive cities to record and it only stays competitive by offering unrivalled, world-class service in terms of quality and speed. The latter means that, despite the expense, clients know that they will need less time in the studio to produce a superior product. If here is any danger of recording time being lost to noise from the building works, clients will simply go to Munich, Prague, Brussels or any of the many cities that compete with London.

Having to suspend operations for six months is certain to result in Air Lyndhurst's permanent closure. Once the studio has been forced to shut its doors, it is very unlikely that anyone will invest the considerable amount of money needed to reopen another large studio to replace it. The net result will be that London, at present one of the major music recording centres of the world, will see its music and film industries go into decline.

I believe that this is the second application made for works on the site. I also understand that the plans are substantially identical to the first planning application which is yet to be decided. This appears to be an attempt to manipulate the planning process in a deeply cynical manner particularly as objections to the first application will not automatically be applied to this one. I would argue that, in order to avoid further attempts so sidestep reasonable challenges, the planning committee should use any power it has to place a permanent restriction on works on that site which would impact on local businesses.

Air Lyndhurst is a vital part of the UK music industry and its closure will have serious consequences for the entire industry. There are only two recording studios of this size in London but, at the same time, tens of thousands of houses in the Borough

of Camden. If the family making this application have such a vital need of a basement to their property, it is perfectly possible for them to find a house in the borough where they can do that work without disastrous consequences for their neighbours and threatening the livelihoods of many people.
